I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to receive and file: An Extension of Time to the Joint Participation Agreement (JPA) with the Florida Department of Transportation (FDOT) for Aircraft Rescue and Fire Fighting (ARFF) Facility Improvements at Palm Beach International Airport (PBI); Financial Project Number 436389-1-94-01 approved by the Board on March 22, 2016 (R-2016-0326 and R-2016-0327), until June 30, 2021.

Summary: The existing ARFF facility is over 40 years old. The Department of Airports (Department) commenced planning efforts to rehabilitate and improve the existing ARFF facility; however, as a result of the planning process, it became apparent that building a new ARFF facility was more feasible than rehabilitating the existing facility. Approval of this time extension will allow for the completion of minor repairs to the existing ARFF facility while the final design package for the new facility is completed. The Extension of Time to the JPA extends the availability of grant funding to allow for the continuation of the project. Delegation of authority for execution of the above Extension of Time to the JPA with the FDOT was approved by the Board on October 18, 2011 (Agenda Item No. 3F11). **Countywide (AH)**

Background and Justification: The Department is in the process of completing the design for a new ARFF facility while making minor repairs to the roof of the existing facility to extend its useful life. Approval of this time extension will ensure that grant funding remains available pending completion of the final design of the new ARFF facility.
