I. EXECUTIVE BRIEF

Summary: The Board was established by Special Act, Laws of Florida, Chapter 67-1876, as amended. The Special Act and, subsequently, Section 489.131, Florida Statutes (F.S.) sets forth the membership of the Board, which consists of 15 members. This Board shall be comprised of fifteen (15) members as follows: two (2) general contractors, one (1) building contractor, one (1) residential contractor; one (1) electrical contractor; one (1) plumbing contractor; one (1) HARV contractor; one (1) roofing contractor; one (1) swimming pool contractor; one (1) architect; one (1) engineer and one (1) full-time building official employed by a local government within Palm Beach County, who meets the requirements of the Building Officials Association of FL; and three (3) consumer representatives. The Board establishes qualifications and competency of contractors that work within the County. The Board also provides for the testing and licensing of these contractors, and is empowered to revoke licenses, and hear citation appeals.

A memorandum was sent to the Board of County Commissioners (BCC) on February 12, 2021 requesting support for the two new board members, no other nominations were received. The Board has ten out of fifteen seats currently filled and a diversity count of Caucasian: 7 (70%), African-American: 1 (10%), Hispanic: 1 (10%) and Native-American: 1 (10%) making the Board 30% diverse. The gender ratio (female: male) is 2:8. Richard Kaplan is a Caucasian male and Aida Vidal is a Hispanic-American female. Staff is addressing the need to increase diversity within our boards and will continue to encourage this in an effort to expand the Board's diversity. Countywide (SF)

Background and Justification: The membership of the Board consists of two general contractors, and one member of the following categories: building, residential, electrical, plumbing, HARV (Heating, Air Conditioning, Refrigeration and Ventilation), roofing, swimming pool, architect, engineer, and building official. In addition, Section 489.131, F.S. requires that we have three Consumer Representatives. The Board establishes qualifications and competency of contractors that work within the County. The Board also provides for the testing and licensing of these contractors, and is empowered to discipline licenses.



ITEM: The purpose of this memo is to request your support for the appointment of two new board members to the Construction Industry Licensing Board (CILB). The nominees are as follows: Mr. Richard Kaplan to serve as the plumbing contractor, seat 8: and Ms. Veronica Vidal to serve as consumer representative, seat 13. All terms for the nominees would begin on April 6, 2021 through September 30, 2024.

BACKGROUND: The primary function of the CILB is for approval and discipline of certificate of competency construction trade licenses for Palm Beach County. The CILB consists of twelve specified construction trade members per Special Act, including three consumer members who may be appointed by the Board of County Commissioners (BCC), establishing 15 active members. The term of office of each member is three years, with one additional 3-year term subject to the BCC approval. The meetings are held once a month on the fourth Monday of each month except for the month of November and holidays permitting. The qualification to be appointed to this board is to be actively engaged in the construction business in Palm Beach County: hold a certificate of competency under the nominee's name; engaged for a period of not less than five consecutive years immediately before the date of his appointment; and be a resident of Palm Beach County. The architect and engineer member shall be licensed in the State of Florida and be a resident of Palm Beach County. The consumer representative may be any resident of the local jurisdiction who is not, and has never been, a member or practitioner of a profession regulated by the CILB or a member of any closely related profession.

The CILB has 10 seats currently filled, and a diversity count of one African-American (6.67%); five Caucasians (79.99%); one Native-American (6.67%) and one Hispanic-American (6.67%) making it a 20 %



diverse board. The gender ratio (female: male) is 2:8. Mr. Kaplan is a Caucasian male: Mrs. Vidal is a Hispanic female, this would increase diversity to 26.67 % and participation to 12 members out of 15.

BOARD MEMBER QUALIFICATIONS

Special Act, Laws of Florida, Chapter 67-1876, as amended

Section 3. Construction Industry Licensing Board of Palm Beach County, organization, meetings, powers, duties. —

- (A) The Construction Industry Licensing Board of Palm Beach County is hereby created and composed of the following: two general contractors, one contractor who is primarily engaged in the business of furnishing those services to which a building contractor is limited, one contractor who is primarily engaged in the business of furnishing those services to which a residential contractor is limited, one electrical contractor, one plumbing contractor, one HARV contractor, one roofing contractor, one swimming pool contractor, one architect, one engineer, and one full-time building official, employed by a local government within Palm Beach County who meets the requirements of the Building Officials Association of Florida. All members of the Board shall be appointed by the Palm Beach County Board of County Commissioners.
- (B) To be eligible for appointment each contractor member shall be:
 - (1) Actively engaged in the construction business in Palm Beach County and have held a certificate of competency in his name and have been so engaged for a period of not less than 5 consecutive years immediately before the date of his appointment, and be a resident of Palm Beach County. The architect and engineer member shall be licensed in the State of Florida and be a resident of Palm Beach County.
 - (2) Each member of the Board except the Building Official shall hold a valid certificate issued by this Board or the state of Florida in addition to having the qualifications required in subsection (B) (1) above.
- (C) All terms of office expire on September 30 of the last year of term. As the terms of members expire, the Board of County Commissioners shall appoint a member to fill the vacancy for a term of 3 years, but no member shall serve for more than two consecutive terms but may be reappointed after a three (3) year hiatus. Vacancies in the membership of the board for any cause shall be filled by the Board of County Commissioners for the balance of the unexpired term.

F.S. § Section 489.131 Applicability:

(10) No municipal or county government may issue any certificate of competency or license for any contractor defined in s. 489.105(3)(a)-(o) after July 1, 1993, unless such local government exercises disciplinary control and oversight over such locally licensed contractors, including forwarding a recommended order in each action to the board as provided in subsection (7).

Each local board that licenses and disciplines contractors must have at least two consumer representatives on that board. If the board has seven or more members, at least three of those members must be consumer representatives. The consumer representative may be any resident of the local jurisdiction who is not, and has never been, a member or practitioner of a profession regulated by the board or a member of any closely related profession. (7/1/93)
