## I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to receive and file:** Amendment No. 5 to Agreement for Provision of Ryan White Part A HIV Support Services with Compass, Inc. (R2018-0223), for the period March 1, 2020 through February 28, 2021, to increase funding by \$254,702, for a new Grant Year (GY) 2020 total amount not-to-exceed \$1,355,126, for an overall total agreement amount not-to-exceed \$3,169,528.

Summary: On April 2, 2020, the U.S. Department of Health and Human Services, Health Resources and Services Administration (HRSA) issued a final notice of award. A revised notice of award was received on September 14, 2020 from HRSA, issuing carryover funding for the prior grant year to the current grant year in the amount of \$249,067. The total grant award for GY 2020, was \$7,707,875. This amendment increased the total agreement amount in core and support services categories for GY 2020 and allowed the agency to provide health insurance premium and cost-sharing assistance to 20 current clients and 17 new clients enrolled in the Affordable Care Act Marketplace Plans for 2021. The funding allowed the Community Services Department to continue funding much needed medical and support services to Palm Beach County residents with HIV/AIDS. Lysette Perez is an employee of Compass, Inc. and is a member of the HIV CARE Council. The HIV CARE Council provides no regulation, oversight, management, or policy-setting recommendation regarding the agency listed above. Disclosure of this contractual relationship at a duly noticed public meeting is being provided in accordance with the provisions of Section 2-443, of the Palm Beach County Code of Ethics. The amendment was executed by the County Administrator in accordance with Agenda Item 3E-3, dated June 16, 2020, which delegated signature authority to the County Administrator, or designee. In accordance with County PPM CW-O-051, all delegated contracts, agreements, and grants must be submitted by the initiating department as a receive and file agenda item. These are Ryan White Part A grant funds, which require no local match. (Ryan White Program) Countywide (HH).

**Background and Justification**: Palm Beach County Board of County commissioners has been receiving this grant since 1994, and has assisted thousands of persons with HIV/AIDS with medical and support services.

RE: Grant Year 2020 – Ryan White Program Amendment

In accordance with BCC approval granting signature authority to the County Administrator, or designee, on June 16, 2020 (Agenda Item 3E-3), your signature is needed on Amendment No. 5 to the Agreement for Provision of Ryan White Part A HIV Support Services with Compass Inc., for the period, March 1, 2020 through February 28, 2021, to increase the total agreement by \$254,702 for a new GY 2020 total amount not-to-exceed \$1,355,126, as approved by the Palm Beach County HIV CARE Council. The total grant award for the 3 year period is now \$3,169,528. This amendment will increase the total agreement amount in core and support services categories for GY 2020 and allow the agency to provide health insurance premium and cost-sharing assistance to 20 current clients and 17 new clients enrolled in the Affordable Care Act (ACA) Marketplace Plans for 2021. No County match is required.

The total grant award for Gant Year (GY) 2020 is \$7,455,808. A revised notice of award was received on September 14, 2020 from the U.S. Department of Health and Human Services, Health Resources and Service Administration (HRSA), issuing carryover funding for the prior grant year to the current grant year in the amount of \$249,067.00. The total grant award for GY 2020, including this notice of award is \$7,707,875.00. This funding allows the Community Services Department (CSD) to continue funding much needed medical and support services to Palm Beach County (PBC) residents with HIV/AIDS.

The emergency signature process is being utilized because there is not sufficient time to submit the amendment through the regular Board of County Commissioner's agenda process due to the termination of the grant period from the funder on February 28, 2021.

#### **I. EXECUTIVE BRIEF**

Motion and Title: Staff recommends motion to:

**A) receive and file** a final Notice of Award (NOA) Grant Award No. 6 H89HA00034-27-01 from the U.S. Department of Health and Human Services, Health Resources and Services Administration (HRSA), for the budget period March 1, 2020 through February 28, 2021, in the amount of \$7,458,808, for new and existing programs to continue improving health outcomes for people living with HIV;

**B)** approve a budget amendment of \$3,171,166 in the Ryan White Care Program fund to align the budget with the actual grant award; and

**C) authorize** the County Administrator, or designee, to execute Ryan White subrecipient funding agreements, amendments, and other documents necessary to align with actual allocations of the grant award.

**Summary:** A final NOA was received on April 2, 2020 from HRSA. The total grant award for the Grant Year (GY) 2020, including this final NOA is \$7,458,808. This award amount is an increase of 1.5% or \$108,564 from GY 2019, after receiving a decrease in funding each year for the prior 5 years. On November 5, 2019, the Board of County Commissioners (BCC) ratified the Mayor's signature on the Ryan White Part A HIV Emergency Relief Grant Program application (R2019-1723). On May 5, 2020, the BCC approved a partial NOA for \$1,494,582. The grant allows the Community Services Department to continue providing needed medical and support services to Palm Beach County residents living with HIV/AIDS. In GY 2019, 3,155 clients were served with a viral suppression rate of 83%. Funding for GY 2020 will provide resources to support a minimum of 45 additional clients (3,200 total) with a goal to increase viral suppression rate to 85%. Some of the services provided under this grant are outpatient medical care, medical case management, pharmaceutical assistance, oral health care, mental health services, substance use disorder treatment, legal support services, health insurance premium assistance, food bank, medical transportation, home delivered meals and psychosocial support services. **No County match is required.** (Ryan White Program) <u>Countywide (HH)</u>

## AMENDMENT TO CONTRACT FOR PROVISION OF RYAN WHITE PART A HIV HEALTH SUPPORT SERVICES

THIS AMENDMENT TO CONTRACT FOR PROVISION OF RYAN WHITE PART A HIV HEALTH SUPPORT SERVICES (R2018-0223) ("Agreement"), made and entered into at West Palm Beach Florida, on this  $26^{+1}$  day of 100 ruary 20 2) by and between Palm Beach County, a Political Subdivision of the State of Florida, by and through its Board of Commissioners, hereinafter referred to as the COUNTY, and <u>COMPASS, Inc.</u>, hereinafter referred to as the AGENCY, a not-for-profit corporation authorized to do business in the State of Florida, whose Federal Tax I.D. is <u>65-0052657</u>.

In consideration of the mutual promises contained herein, the COUNTY and the AGENCY agree as follows:

## WITNESSETH:

WHEREAS, on March 13, 2018 (R2018-0223), the above named parties entered into a three-year Agreement to provide services in the areas of Core Medical and Support Services in an annual amount of \$843,796; and

WHEREAS, the Agreement was amended on February 5, 2019 (R2019-0197), to: increase funding for Special Outpatient Medical Care by replacing Exhibit A - Work Plans with Exhibit A1 – Work Plans, and Exhibit B - Units of Service Rate and Definitions with Exhibit B2 – Unit of Service Rate and Definitions; add Exhibit D – Sub-Award Data, and Article 31 - Criminal History Records; and update Article 9 – Nondiscrimination, Article 14 – Termination, and Article 23 – Scrutinized Companies; and

WHEREAS, the Agreement was amended on May 7, 2019 (R2019-0587), to: decrease overall funding by replacing Exhibit A1 – Work Plans with Exhibit A2 – Work Plans, Exhibit B1 - Units of Service Rate and Definitions with B2 – Units of Service Rate and Definitions, and Exhibit D – SubAward Data with Exhibit F – SubAward Data; update Article 3 – Payments to Agency/Reimbursable, Article 9 – Nondiscrimination, Article 10 – Agency's Programmatic Contracts, and Article 13 – Amendments to Funding Levels; and add Exhibit G – Service Categories; and

WHEREAS, the Agreement was amended on May 5, 2020 (R2020-0410), to: change overall funding by replacing Exhibit A2 – Work Plans with A3 – Work Plans, Exhibit B2 - Units of Service Rate and Definitions with Exhibit B3 - Units of Service Rate and Definitions, and Exhibit F – SubAward Data with F2 – SubAward Data; and update Article 3 – Payment to Agency/Reimbursable, Article 4 – Schedule, Article 9 – Nondiscrimination, Article 10 – Agency's Programmatic Contracts, Article 23 – Scrutinized Companies, and Article 31 – Criminal History Records Check; and

WHEREAS, the Agreement was amended on January 12, 2021 (R2021-0031) to: replace Exhibit A3 - Work Plans with A4 - Implementation Plans, Exhibit B3 - Units of Service Rate and Definitions with Exhibit B4 - Units of Service Rate and Definitions, and Exhibit F2 - SubAward Data with F3 - SubAward Data; add Exhibit D - Ryan White Notification Form, Exhibit H - Use of and Restrictions Regarding the Premises, Attachment 1 - Certifications, Attachment 2 - Assurances, Non Construction Programs, Attachment 3 - Assurance of Compliance, and Attachment 4 - Cash Flow Commitment; update Article 3 - Payments to Agency/Reimbursable, Article 9 - Nondiscrimination, Article 10 - Ryan

White Funded Agency's Programmatic Requirements, and Article 13 – Amendments to Ryan White Agency Funding Levels; add Article 32 – Sub-Contracting, Article 33 – Contracting with Small and Minority Businesses, Article 34 – Hiring of Mechanic or Laborers, Article 35 – Authority to Practice, Article 36 – Discriminatory Vendor List, Article 37 - Federal and State Tax, Article 38 – Facilities/Office Space, Article 39 – Debarment and Suspension, Article 40 – Federal System for Award Management, Article 41 – Clean Air Act and the Federal Water Pollution Control Act, Article 42 – Scientific Research and Development and Copyright and Patent Rights, Article 43 – Mandatory Standards and Policies Relating to Energy Efficiency, Article 44 – Procurement of Recovered Materials, Article 45 – Program Fraud and False or Fraudulent or Related Acts, Article 46 – Federal Criminal Law/False Statements Act, Article 47 – Regulations; Article 48 – Counterparts, and Article 49 – E-Verify Employment Eligibility; and

WHEREAS, the need exists to amend the Agreement to replace Exhibit B4 - Units of Service Rate and Definitions with Exhibit B5 - Units of Service Rate and Definitions, and Exhibit F4 – SubAward Data with F5 – SubAward Data; update Article 5 – Payments to Ryan White HIV/AIDS Program Funded Agency, Article 19 – Ryan White HIV/AIDS Program Funded Agency Programmatic Requirements, and Article 49 – E-Verify Employment Eligibility

**NOW, THEREFORE**, the above named parties hereby mutually agree that the Agreement entered into on March 13, 2018, as amended on February 5, 2019, May 7, 2019, May 5, 2020 and January 12, 2021 is hereby amended as follows:

- I. The whereas clauses above are true and correct and are expressly incorporated herein by reference and made part of the parties' Agreement
- II. Exhibit B5 Units of Service Rate and Definitions, attached hereto, shall replace in its entirety Exhibit B4 Units of Service Rate and Definitions.
- III. Exhibit F5 SubAward Data, attached hereto, shall replace in its entirety Exhibit F4 SubAward Data.
- IV. ARTICLE 3 PAYMENTS TO RYAN WHITE HIV/AIDS PROGRAM FUNDED AGENCY shall be replace in its entirety with the following:

The total amount to be paid by the COUNTY under this Agreement for all services and materials shall not exceed a total Agreement amount of <u>THREE MILLION, ONE HUNDRED SIXTY-NINE THOUSAND, FIVE HUNDRED AND TWENTY-EIGHT DOLLARS AND ZERO CENTS (\$3,169,528.00) OF WHICH, EIGHT HUNDRED AND THREE THOUSAND, FIVE HUNDRED AND NINETY-SEVEN DOLLARS AND ZERO CENTS (\$803,597.00) IS BUDGETED IN GRANT YEAR 2018, ONE MILLION, TEN THOUSAND, EIGHT HUNDRED AND FIVE DOLLARS AND ZERO CENTS (\$1,010,805.00) IS BUDGETED IN GRANT YEAR 2019, AND ONE MILLION, THREE HUNDRED FIFTY-FIVE THOUSAND, ONE HUNDRED AND TWENTY-SIX DOLLARS AND ZERO CENTS (\$1,355,126.00) IS BUDGETED IN GRANT YEAR 2020.</u>

The AGENCY will bill the COUNTY on a monthly basis, by the twenty-fifth (25th) day of each month, for services performed at actual cost of service. Failure to submit monthly Service Utilization Reimbursement Requests and required reports in a manner deemed correct and acceptable by the COUNTY, by the twenty-fifth (25th) day of each month following the month

in which services were delivered shall deem the Service Provider(s) in non-compliance with this covenant and at the option of the COUNTY, the Service Provider will forfeit its claim to any reimbursement for that specific month's reimbursement request or the COUNTY may invoke the termination provision in this Agreement. Any travel authorized for reimbursement must meet the condition set forth in section 112.061, Florida Statutes, and Palm Beach County PPM #CW-F-009. All Requests for Payment under the terms of this Agreement shall include documents acceptable to the Community Services Department. The final invoice under this Agreement must be labeled "Final Invoice" and must be received by the COUNTY not later than March <u>31st of each fiscal year that this Agreement is in effect</u>.

Invoices received from the AGENCY pursuant to this Agreement will be reviewed for authenticity and accuracy and approved by the DEPARTMENT to verify that services have been rendered in conformity with this Agreement and then will be sent to the Finance Department for payment. Funding changes between service categories, if prior funding allocations have been altered and approved by the HIV CARE Council within the designated Agreement, can be approved, in writing, by the DEPARTMENT Director or Assistant Director at their discretion for up to ten percent (10%) of the total Agreement amount during the Agreement period. Changes in excess of ten percent (10%) of the annual Agreement amount during the Agreement period must be approved by the Palm Beach County Board of County Commissioners.

In order to do business with Palm Beach County, agencies are required to create a Vendor Registration Account OR activate an existing Vendor Registration Account through the Purchasing Department's Vendor Self Service (VSS) system, which can be accessed at <u>https://pbcvssp.co.palm-beach.fl.us/webapp/vssp/AltSelfService</u>. If AGENCY intends to use subagencies, AGENCY must also ensure that all subagencies are registered as agencies in VSS. All subcontractor agreements must include a contractual provision requiring that the subagency register in VSS. COUNTY will not finalize an award until the COUNTY has verified that the AGENCY and all of its subagencies are registered in VSS.

V. ARTICLE 10 - RYAN WHITE FUNDED AGENCY'S PROGRAMMATIC CONTRACTS shall include the following information:

54 The COUNTY has a requirement to ensure that at least 75% of RWHAP direct service funds are expended in Core Medical Services. Legislative authority for RWHAP service category priority-setting and resource allocation lies solely with the Palm Beach County HIV CARE Council, whose decisions may require changes in the Agreement. The COUNTY will monitor the expenditure of funds throughout the Agreement year to insure that the COUNTY is meeting federal requirements. The AGENCY agrees and understands that Support Services funding may be reduced in order to meet federal requirements. The AGENCY MUST notify COUNTY of its under spending in Core Medical Services in writing by the 15th of each month following a month when AGENCY has under spent Core Medical Services based on the anticipated rate of expenditures. The anticipated rate of expenditures is determined by dividing the Agreement service amount by the months in the Agreement unless otherwise provided. AGENCY'S failure to spend Core Medical Services funding may result in withholding Support Services reimbursements or redistributing funding to other agencies.

# VI. <u>ARTICLE 49 - E-VERIFY - EMPLOYMENT ELIGIBILITY</u> is amended to read as follows:

Agency warrants and represents that it is in compliance with section 448.095, Florida Statutes, as may be amended, and that it: (1) is registered with the E-Verify System (E-Verify.gov), and beginning January 1, 2021, uses the E-Verify System to electronically verify the employment eligibility of all newly hired workers; and (2) has verified that all of Agency's subagencies performing the duties and obligations of this Agreement are registered with the E-Verify System, and beginning January 1, 2021, use the E-Verify System to electronically verify the employment eligibility of all newly hired workers.

Agency shall obtain from each of its subagencies an affidavit stating that the subagencies does not employ, contract with, or subcontract with an Unauthorized Alien, as that term is defined in section 448.095(1)(k), Florida Statutes, as may be amended. Agency shall maintain a copy of any such affidavit from a subagencies for, at a minimum, the duration of the subcontract and any extension thereof. This provision shall not supersede any provision of this Agreement which requires a longer retention period.

COUNTY shall terminate this Agreement if it has a good faith belief that Agency has knowingly violated Section 448.09(1), Florida Statutes, as may be amended. If COUNTY has a good faith belief that Agency's subagencies has knowingly violated section 448.09(1), Florida Statutes, as may be amended, COUNTY shall notify Agency to terminate its contract with the subagencies and Agency shall immediately terminate its contract with the subagencies. If COUNTY terminates this Agreement pursuant to the above, Agency shall be barred from being awarded a future contract by COUNTY for a period of one (1) year from the date on which this Agreement was terminated. In the event of such contract termination, Agency shall also be liable for any additional costs incurred by COUNTY as a result of the termination.
