### FIRST AMENDMENT TO SIGNATORY AIRLINE AGREEMENT BETWEEN PALM BEACH COUNTY AND AMERICAN AIRLINES, INC.

THIS FIRST AMENDMENT TO SIGNATORY AIRLINE AGREEMENT (this "First Amendment") is made and entered into this \_March \_15 \_\_\_\_\_, 20\_21\_, by and between Palm Beach County, a political subdivision of the State of Florida ("County"), and American Airlines, Inc., a Delaware corporation, having its offices and principal place of business at 1 Skyview Drive, MD 8E100, Fort Worth, Texas 76155 ("Airline").

WHEREAS, County, by and through its Department of Airports (the "Department"), owns and operates the Palm Beach International Airport, located in Palm Beach County, Florida: and

**WHEREAS**, pursuant to the Signatory Airline Agreement between County and Airline dated October 7, 2019 (R-2020-0223) (the "Agreement"), Airline leases various terminal facilities and equipment at the Airport in connection with its operations as a commercial air carrier; and

WHEREAS, the parties desire to amend the Agreement as provided for herein.

**NOW, THEREFORE,** in consideration of the premises and of the mutual covenants herein contained, and for other good and valuable consideration, the receipt of which the parties hereby expressly acknowledge, the parties hereto covenant and agree to the following terms and conditions:



- 4. Except as specifically modified herein, all of the terms and conditions of the Agreement shall remain unmodified and in full force and effect and are hereby ratified and confirmed by the parties hereto.
- 5. This First Amendment shall become effective as of December 23, 2020.



#### <u>First Level Plan – Palm Beach International Airport Main Terminal</u>





### <u>First Level Plan – Palm Beach International Airport Concourse "B"</u>




