| Motion and Title: Staff recommends motion to ratify: the Mayor's signature on the Letter of Support to work collaboratively with Florida State University (FSU) and the College of Criminology and Criminal Justice on the project being submitted by FSU under the solicitation for Research and Evaluation of Services for Victims of Crime, Fiscal Year 2021 (O-NIJ-2021-40005).  |              |                      |          |                           |
| Summary: The U.S. Department of Justice (DOJ) Office of Justice Programs (OJP), National Institute of Justice (NIJ), in collaboration with the Office of Victims of Crime (OVC), is seeking applications for a rigorous program evaluation of specific services for victims of crime. The Palm Beach County Division of Victim Services (DVS) and the FSU College of Criminology and Criminal Justice have successfully partnered with Drs. Turanovic, Pesta and Blomberg on prior research funded by OVC. The proposed project will evaluate the comprehensive services provided by DVS for all crime types, victims and survivors. Ultimately, the evaluation will lead to the identification of model victim service protocols, which can be replicated and evaluated in other jurisdictions. NIJ expects to make multiple awards with an estimated total amount awarded of up to \$4 million. The emergency signature process was utilized because there was not sufficient time to submit the letter through the regular agenda item process to meet the March 2, 2021 deadline. | Background and Justification: The NIJ is interested in evaluations of different types of victim services including, but not limited to, programs embedded in hospitals/trauma centers; umbrella/network organizations; one-stop victim services programs; and/or programs embedded in criminal justice agencies (CFDA 16.560). Completing the formative evaluation and evaluability assessment should not exceed a 24-month performance period. This application, if funded, would allow FSU to evaluate existing services provided by the DVS in order to enhance the existing services, ensure we are using an evidence-based approach to best respond to the needs of our various clients, provide assessments of cost effectiveness and identify impacts on victim advocates. In 2019, FSU applied for this grant (NIJ-2019-15443), however their funding request was denied. The County provided a letter of support signed by Mayor Mack Bernard whose signature was ratified on July 2, 2019 (R2019-0976).  |              |                      |          |                           |

### AN EVALUATION OF PALM BEACH COUNTY VICTIM SERVICES

Florida State University proposal to the National Institute of Justice Research and Evaluation of Services for Victims of Crime (O-NIJ-2021-40005) March 2021

### **Project Overview**

The purpose of the proposed study is to provide a rigorous evaluation of the comprehensive, county-wide victim services model in place in Palm Beach County, Florida. The unique, comprehensive model offered by Palm Beach County Victim Services (PBCVS) includes a range of therapeutic and advocacy services. In evaluating the PBCVS model, we will collect both qualitative and quantitative data to provide a *process evaluation* and an *impact evaluation*. Overall, this evaluation will allow us to identify a set of best practices for victim services, and improve evidence-based service delivery.

The process evaluation will provide a detailed description of:

- how victims and survivors learn about and access victim services;
- how victim services are being implemented and delivered;
- who the services are reaching; and
- the organization's capacity to provide support and therapy to crime victims.

The impact evaluation will assess the effectiveness of PBCVS in producing change and assess its impact on victims and service staff (i.e., victim advocates and therapists). The impact evaluation will also identify:

- areas for improvement in victim services;
- why some victims decline to receive services; and
- the types of programs and services that are most beneficial for victims and survivors of specific crimes (e.g., intimate partner violence victims, sexual assault victims, homicide survivors, and victims of other violent crimes).

### **Data Sources**

For this project, Florida State University (FSU) will request administrative case management data on all victims served by PBCVS since 2017. Should the project require extensive data preparation, FSU will retain a PBCVS-approved contractor to assist with creating the files.

Researchers will also collect information from victims and survivors using electronic surveys and indepth interviews. Data will be collected with victims and survivors who did and did not receive services from PBCVS. Victim assessments will be taken at two time points throughout the project period to assess changes in post-traumatic stress, service needs, and coping skills following participation in various victim services. Focus groups will be conducted with service staff to understand their perspectives on providing victim services, as well as the impacts of service provision on their wellbeing.

### **Deliverables**

Key deliverables will include presentations to PBCVS, the Palm Beach County Criminal Justice Commission, and academic audiences; and a final report summarizing the results of the evaluation along with key policy recommendations. All deliverables will be shared with PBCVS and the National Institute of Justice.

### **Program Description**

### Overview

In collaboration with the Office of Victims of Crime, NIJ is seeking applications in three main areas under this solicitation: 1) research and evaluation of State crime victim compensation programs; 2) research on the impact of COVID-19 on the delivery of services to victims of crime; and 3) evaluation of programs that provide services for victims of crime. Applicants should submit proposals that address one of the three topics.

Applications proposing research involving partnerships with criminal justice or other agencies, should include a strong letter of support, signed by an appropriate decision-making authority from each proposed, partnering agency. A letter of support should include the partnering agency's acknowledgement that de-identified data derived from, provided to, or obtained through this project will be archived by the grant recipient with the National Archive of Criminal Justice Data (NACJD) at the conclusion of the award. Applicants and their potential partners are encouraged to review the NACJD's policies and protections at (NACJD). If selected for award, grantees will be expected to have a formal agreement in place with partnering agencies by January 1, 2022. That formal agreement must include a provision to meet the data archiving requirements of the award.

In the case of partnerships that will involve the use of federal award funds by multiple partnering agencies to carry out the proposed project, only one entity/partnering agency may be the applicant (as is the case with any application submitted in response to this solicitation); any others must be proposed as subrecipients.

### **Statutory Authority**

Any awards under this solicitation would be made under statutory authority provided by a full-year appropriations act for FY 2021. As of the writing of this solicitation, the Department of Justice is operating under a short-term "Continuing Resolution;" no full-year appropriation for the Department has been enacted for FY 2021.

### **Specific Information**

NIJ is seeking applications in three main areas under this solicitation: 1) research and evaluation of State crime victim compensation programs; 2) research on the impact of COVID-19 on the delivery of services to victims of crime; and 3) evaluation of programs that provide services for victims of crime. Applicants should submit proposals that address one of the three topics.

Randomized controlled trial (RCT) studies are a powerful, much-needed tool for building scientific evidence about what works. Therefore, NIJ will give studies employing RCT methods to assess the effectiveness of programs and practices higher priority consideration. RCT applications with strong designs measuring outcomes of self-evident policy importance are strongly encouraged. A strong RCT design should include measures to ensure low sample attrition, sufficient sample size, close adherence to random assignment, valid outcome measures, and statistical analyses. Applicants may want to consider studies using privacy-protected administrative data collected by others, or implement an intervention into a program already funded, as this approach may lower overall study costs.

For applications proposing outcome or impact evaluations, NIJ will only fund projects that evaluate well-developed programs. Applications should include, and append, supplementary materials as necessary to describe the level of program development. Supplemental materials may include copies or links to logic models, program guides and materials, policies and

<u>Note</u>: Funding under this solicitation may only be used to cover costs associated with the evaluation, but may include reasonable costs incurred by program personnel to support activities directly and exclusively required for the execution of the evaluation (e.g., manual extraction of administrative records).

### Research and Evaluation of Crime Victim Compensation Programs

In collaboration with OVC, NIJ seeks proposals for research and evaluation projects examining the effectiveness of State crime victim compensation programs. The body of existing research on victim compensation is largely dated. New research is needed to provide guidance to both practitioners and most especially to policy makers. Questions of interest include but are not limited to program utilization and comprehensiveness (to include compensation for new and emerging crime types) and potential barriers to the same, such as, the impact of the program funding model. Cross-jurisdictional comparisons are encouraged to help identify best practices.

### Evaluation of Programs that Provide Services for Victims of Crime

NIJ seeks proposals for evaluations of programs that deliver services to victims of crime. NIJ is interested in evaluations of different types of victim service programming including, but not limited to, programs embedded in hospitals/trauma centers, umbrella/network organizations, one-stop victim services programs, and/or programs embedded in criminal justice agencies. Applicants are expected to use rigorous research methods in evaluating service delivery programs with preference given to those that employ, or are clearly progressing towards employing experimental research designs. NIJ is seeking both applications for formative evaluations with evaluability assessments and outcome/impact evaluations as described below.

1. NIJ recognizes that many victim service programs may not be ready to support rigorous outcome evaluations; as such, a phased approach may be appropriate. Applicants should plan to conduct a formative evaluation, as well as an evaluability assessment to determine whether an outcome evaluation of the program or model is possible.

Under a phased approach, an applicant may initially propose a range of formative and/or process evaluation activities such as:

- Descriptive research of victim service program(s) leading to the development of a logic model(s).
- Evaluability and research capacity assessments of programs to be studied, including but not limited to access to data and samples, consent procedures, and agency burdens
- Development of an implementation guide for specific program(s).
- Development of instruments or measures to test the fidelity of program(s).
- Description of the process used to design and implement the program.
- Description of program operations, including any changes in the program.
- Identification and description of intervening events that may have affected implementation and outcomes.
- Structured observations, questionnaires, semi-structured interviews, focus groups, and logs.

Award recipients, if successful, may be encouraged or invited to submit a subsequent

application for funding of further evaluation research to build upon its findings from earlier phases. Subsequent phases may include outcome and impact evaluations of specified program(s) or model(s). Future evaluation opportunities out of the phased approach may also include support for replication studies of programs or models. The specifics of the additional phases will be dependent on the findings of the formative evaluation and evaluability assessment, as well as other factors, including, but not limited to, the availability of appropriations.

- 2. Previous NIJ grant recipients who received funding in FY 2018 or FY 2019 to conduct phased evaluative projects may submit applications for the next phase of their evaluations. Applications should state clearly how they will build upon findings from the initial project and how the proposed project will accomplish or make significant strides towards accomplishing a rigorous outcome evaluation of the victim service program.
- 3. In cases where programs have achieved a suitable level of development, NIJ encourages applicants to propose rigorous outcome or impact evaluations, using randomized evaluation designs where it is possible and appropriate to do so. If that is not possible or appropriate, applicants should propose the most rigorous and appropriate design to produce high-quality causal evidence and provide justification for not proposing a more rigorous design.

Research on the Impact of COVID-19 on the Delivery of Services to Victims of Crime

NIJ seeks proposals for research projects to examine the delivery of services to victims of crime before, during, and after the outbreak of the COVID-19 pandemic.
