I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: a contract with R & D Paving, LLC (RDP) in the amount of \$518,149.95 for the construction of Boynton Beach Boulevard and Acme Dairy Road (Project).

SUMMARY: Approval of this contract will provide the construction services necessary to extend a right turn lane on Boynton Beach Boulevard at Acme Dairy Road. The Affirmative Procurement Initiative selected for this contract on October 7, 2020 by the Goal Setting Committee is a 20% minimum mandatory Small Business Enterprise (SBE) participation. RDP contractually agreed to 65.8% SBE participation. RDP was the lowest responsive bidder of nine. The contract time for the Project is 120 calendar days. RDP is a Palm Beach County based company and a certified SBE company. District 5 (YBH)

Background and Justification: Bids for the Project were received by the Engineering Department on January 5, 2021. After reviewing the attached contract and finding it in proper order, the Engineering Department recommends approval by the Board of County Commissioners.
