I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: a contract with Heavy Civil, Inc. (HCI) in the amount of \$353,786.00 for the construction of Hood Road from Briarlake Drive to west of the Florida Turnpike (Project).

SUMMARY: Approval of this contract will provide the construction services necessary to construct an asphalt sidewalk along the north side of Hood Road from the east side of Briarlake Drive to west of the Florida Turnpike. The Affirmative Procurement Initiative selected for this contract on October 21, 2020 by the Goal Setting Committee is a 20% minimum mandatory Small Business Enterprise (SBE) participation. HCI was the lowest responsive responsible bidder of five. HCI contractually agreed to 21.67% SBE participation. The contract time for the Project is 120 calendar days. This Project is included in the infrastructure sales tax. District 1 (YBH)

Background and Justification: Bids for the Project were received by the Engineering Department on January 26, 2021. After reviewing the attached contract and finding it in proper order, the Engineering Department recommends approval by the Board of County Commissioners.
