#### I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to adopt: six resolutions to initiate eminent domain proceedings by declaring the acquisition of properties designated as parcel 103 as right-of-way, parcel 203 as a permanent easement, and parcels 300, 301, 302A and 302B, 304A and 304B, and 305 as temporary construction easements necessary for the construction of roadway improvements on Benoist Farms Road from Southern Boulevard (State Road 80) to Belvedere Road (Project).

SUMMARY: Adoption of these resolutions will initiate eminent domain proceedings pursuant to Chapters 73, 74, 127, and Section 337.27, Florida Statutes as amended, against seven parcels having a total appraised value of \$309,400. The parcels are necessary for the widening and construction of a three-lane roadway with paved shoulders, curb and gutters, a closed drainage system, sidewalks and traffic signal improvements for the Project. To date, the property owners have not accepted the offers to purchase made by Palm Beach County (County) and attempts to negotiate the purchases have been unsuccessful. Eminent domain proceedings are necessary to acquire the parcels at this time in order to expedite construction of the Project. This Project is included in the Five Year Road Program. District 2 (DO)

**Background and Justification:** The acquisition of parcels 103, 203, 300, 301, 302 A & B, 304 A & B, and 305 is for a public purpose and necessity, which is deemed to be in the best interest of the County. The Engineering Department recommends the Board of County Commissioners' approval.
