## I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to approve:** Amendment No. 1 to the Palm Beach County Water Utilities Department (PBCWUD) 2019 Pipeline Continuing Construction Contract (Contract) with Johnson–Davis Incorporated (Contractor) to increase the Contract amount by \$6,000,000 to \$19,797,132.75.

Summary: On February 11, 2020, the Board of County Commissioners approved the Contract (R2020-0160) with the Contractor in the amount of \$13,797,132.75 for a three (3) year term. Since March 15, 2020, PBCWUD has undertaken a total of \$10,039,864.16 of authorized work under the Contract. The requested Amendment No. 1 shall increase contract funding to \$19,797,132.75. The proposed increase of funds will allow for the continuation of necessary services to expedite utility special assessment projects, repair and construction activities on water, wastewater and reclaimed water pipelines throughout PBCWUD's service area where timing is critical. Work will be assigned during a three (3) year period by Work Authorizations (WA) drawn against the Contract, subject to approval pursuant to the requirements of PPM CW-F-050. The unit prices contained in the Contract will be used to determine the amount of each WA. The Contract was presented to the Goal Setting Committee on April 3, 2019, and a minimum mandatory 20% SBE subcontracting goal was the Affirmative Procurement Initiative (API) applied to this Contract. The Contract provides for 20.07% SBE participation. Contractor is a Palm Beach County based Company. (PBCWUD Project No. 19-040) Countywide (MJ)

**Background and Justification:** PBCWUD performs maintenance, repair and construction activities on water, wastewater and reclaimed water pipelines throughout its service area. Amendment No. 1 will reduce the time needed to undertake the installation of infrastructure necessary to complete required utility repairs and improvements, help to improve the service level, restore system reliability, and to provide for utility adjustments associated with road improvement projects.

#### WITNESSETH

WHEREAS, the parties have entered into a Contract under which the CONTRACTOR provided certain professional services to the COUNTY for various projects in accordance with the contract for the:

## 2019 Pipeline Continuing Construction Contract Contract No. WUD 19-040

WHEREAS, the parties hereto desire to amend the Contract to increase the Contract amount by \$6,000,000 from \$13,797,132.75 to \$19,797,132.75 to allow for the continuation of maintenance, repair and construction activities on water, wastewater and reclaimed water pipelines throughout the service area, and to update the Contract to include E-Verify language.

NOW, THEREFORE, in consideration of the premises and of the mutual covenants hereinafter set forth and for such other good and valuable consideration, the receipt of which the parties hereto expressly acknowledge, the parties covenant and agree to the following terms and conditions:

1. The not to exceed amount is hereby increased by \$6,000,000 from \$13,797,132.75 to \$19,797,132.75.

2. The following language is added to the Contract as General Condition No. 81:

CONTRACTOR warrants and represents that it is in compliance with section 448.095, Florida Statutes, as may be amended, and that it: (1) is registered with the E-Verify System (E-Verify.gov), and beginning January 1, 2021, uses the E-Verify System to electronically verify the employment eligibility of all newly hired workers; and (2) has verified that all of CONTRACTOR's subcontractors performing the duties and obligations of this Contract are registered with the E-Verify System, and beginning January 1, 2021, use the E-Verify System to electronically verify the employment eligibility of all newly hired workers.

CONTRACTOR shall obtain from each of its subcontractors an affidavit stating that the subcontractor does not employ, contract with, or subcontract with an Unauthorized Alien, as that term is defined in section 448.095(1)(k), Florida Statutes, as may be amended. CONTRACTOR shall maintain a copy of any such affidavit from a subcontractor for, at a minimum, the duration of the subcontract and any extension thereof. This provision shall not supersede any provision of this Contract which requires a longer retention period.

COUNTY shall terminate this Contract if it has a good faith belief that CONTRACTOR has knowingly violated Section 448.09(1), Florida Statutes, as may be amended.

If COUNTY has a good faith belief that CONTRACTOR's subcontractor has knowingly violated section 448.09(1), Florida Statutes, as may be amended, COUNTY shall notify CONTRACTOR to terminate its contract with the subcontractor and CONTRACTOR shall immediately terminate its contract with the subcontractor.

If COUNTY terminates this Contract pursuant to the above, CONTRACTOR shall be barred from being awarded a future contract by COUNTY for a period of one (1) year from the date on which this Contract was terminated. In the event of such contract termination, CONTRACTOR shall also be liable for any additional costs incurred by COUNTY as a result of the termination.

3. Except as specifically modified above, the terms and conditions of the Contract dated February 11, 2020, are hereby confirmed and remain in full force and effect.
