The County has expended or encumbered \$639,724 (\$45,695/month) during the previous fourteen (14) months of the current fifteen (15) month term contract, which includes a three (3) month extension pursuant to the Purchasing Director's authority. Due to the impact of the COVID-19 pandemic, resulting in staff workload reprioritization and the periodic non-availability for work, an additional nine (9) month extension to the current term contract is necessary to solicit and award a new term contract and to avoid a gap in service. This term contract will be terminated for convenience upon award of a new term contract. In addition, an increase of \$253,200 over the previously authorized amount of \$726,000, inclusive of the Purchasing Director's ten percent (10%) authority, is required in order to continue elevator/escalator maintenance and repair during the contract extension.
