Motion and Title: Staff recommends motion to approve: a contract with Municipal Contractors, Inc. (MCI) in the amount of \$894,568.50 for the construction of the Clint Moore Road at Jog Road Intersection Improvements (Project).

SUMMARY: Approval of this contract will provide the construction services necessary to add a third through lane in the westbound direction on Clint Moore Road at Jog Road. The Affirmative Procurement Initiative selected for this contract on August 5, 2020 by the Goal Setting Committee is a 20% minimum mandatory Small Business Enterprise (SBE) participation. MCI contractually agreed to 82.4% SBE participation. MCI was the lowest responsive bidder of eight. The contract time for the Project is 150 calendar days. MCI is a Palm Beach County based company and a certified SBE company. This Project is included in the Five-Year Road Program. District 4 (YBH)
