### I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to approve:** Amendment No. 1 to the General Consulting Agreement with HDR Engineering, Inc. (HDR) for Consulting/Professional Services, to exercise the first one (1) year renewal option for the continued performance of professional planning and design services related to the approved Palm Beach County Airports Capital Improvement Program.

**Summary:** The Consulting Agreement with HDR for general airport planning and design was approved by the Board on August 20, 2019 (R-2019-1157) in the amount of \$960,107 in order to carry out the approved Capital Improvement Programs for the County's Airports. Approval of Amendment No. 1 will allow the County, at its sole discretion, to exercise the first one-year renewal option for the continuation of services provided under this agreement. HDR is a Omaha, Nebraska based firm; however, the majority of the work to be completed in this agreement will be managed through their West Palm Beach, Florida office in conjunction with several Palm Beach County-based and South Florida-based subconsultants and firms. A Disadvantaged Business Enterprise (DBE) goal of 20% was set for this contract. HDR committed to 20% DBE participation for this agreement. The current paid to date DBE participation is approximately 14%. The DBE participation for this Amendment is 0% as no new tasks are being proposed. As new tasks are developed and approved throughout the period of performance for this agreement, the overall DBE participation is expected to increase in order to satisfy HDR's commitment of 20%. **Countywide (AH)** 

**Background and Justification:** In order to carry out the approved Capital Improvement Program for the County, the Department of Airports requires professional planning and design engineering services. This agreement is for 2 years with 2 one (1) year renewal options. The base agreement expires on August 19, 2021, thus requiring the renewal option to ensure continuation of the services provided by the Consultant under this agreement. Approval of Amendment No. 1 allows for the continuation of services necessary for the development and operation of the County's airport system.


