I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Appointments of two At-Large members to the Natural Areas Management Advisory Committee (NAMAC). Seat Nos. 3 and 7 are for a term of two years and one month beginning August 17, 2021 through September 30, 2023.

Summary: Resolution No. R2013-1328 provides for a seven-member NAMAC. Membership consists of one member with experience in the management of natural areas, one biological scientist, one professional educator with knowledge of South Florida ecosystems, one representative of a local municipal government parks and recreation program, one member of the Palm Beach County Parks and Recreation Department staff, and two citizens having an interest in preservation and conservation of natural areas. With these two appointments, all seven seats will be filled and diversity count of Caucasian: 5 (71%), African American: 1 (14.5%) and Hispanic: 1 (14.5%). The gender ratio (female:male) is 5:2. Seat No. 3 nominee is a Caucasian female and Seat No. 7 is an African American female. Staff continues to address the need for increased diversity within our boards and will encourage expansion of this Board's diversity. Countywide (SS)

Background and Justification: The purpose of NAMAC is to review and comment on management plans developed by staff for natural areas and conservation lands managed by the Palm Beach County Department of Environmental Resources Management, with a specific focus on proposed public uses of these sites and to make recommendations to staff on possible changes to each plan prior to making a recommendation to the Board of County Commissioners on approval of the plan. Dr. Miles meets the criteria to fill Seat No. 3 and would be serving her first term. Ms. McMillan meets the criteria to fill seat No. 7 and would be serving her first term. The two appointments are for three-year terms expiring September 30, 2023, however, due to a delay in the reappointments the actual term is two years and one month.
