The County has expended or encumbered \$834,657 (\$21,965/month) during the previous thirty-eight (38) months of the current sixty (60) month term contract. Water Utilities Department requests an increase of \$107,184 over the previous authorized amount of \$1,071,840, inclusive of the Purchasing Director's ten percent (10%) authority, for the remaining twenty-two (22) months of the current term contract. This increase is necessary due to the need for replacement of an aging low voltage feeder at the Belle Glade Wastewater Facility. Approval is also requested to add vendors that may become pre-qualified during the term of this contract. Pre-qualification contracts allow for the addition of new vendors during the full term of the term contract. This term contract has no renewal options. Eight (8) Awardees are located in Palm Beach County and one (1) Awardee is located outside Palm Beach County in the City of Fort Lauderdale, Florida.

Palm Tran requested a term contract for gateway processing services for Genfare ticket vending machines. Vendor, a sole source, requires that the County agree to a limitation of liability provision that deviates from the County's standard. The limitation of liability limits Vendor's liability for direct damages to the amount of fees the County has paid to Value Payment Systems, LLC ("VPS") under the agreement without any limitation of liability for vendor's gross negligence or willful misconduct. The limitation of liability is not applicable to vendor's indemnification of the County for all third party claims. In accordance with PPM CW-F-049, the Department of Risk Management and the County Attorney's Office have approved the limitation of liability. These negotiated terms between Palm Beach County and VPS will be used for future sole source purchases, as applicable. This term contract has two (2) twelve (12) month renewal options remaining. Awardee is located out of State. Awardee is a sole source provider who is not a certified S/M/WBE. This sole source contract is exempt from the EBO Ordinance.

The County has expended or encumbered \$263,819 (\$25,126/month) as an advance lump sum payment, which covers the current twelve (12) month term contract. Due to the need for continued maintenance of the CAD/AVL system and additional new products that are necessary in order to comply with FTA Safety Advisory SA 20-1, \$374,921 is needed to meet the County's requirements through the expiration of this new twelve (12) month renewal term contract. The contract amount and expended amount for the: (i) initial twelve (12) month term was \$204,682; (ii) first twelve (12) month renewal term was \$239,292; (iii) second twelve (12) month renewal was \$251,256; and (iv) third twelve (12) month renewal term was \$263,819. This term contract has no renewal options remaining. Awardee is located out of State. Awardee is a sole source provider who is not a certified S/M/WBE. This sole source contract is exempt from the EBO Ordinance.
