I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Amendment No. 2 to the annual small paving and minor construction contract (R2019-1833) dated December 3, 2019 (Contract) with R & D Paving, LLC (RDP) to increase the amount of the contract by \$100,000 and to extend the expiration date from December 2, 2021 to December 2, 2022.

SUMMARY: Approval of this amendment will increase the Contract amount from \$3,000,000 to \$3,100,000 and extend the expiration date from December 2, 2021 to December 2, 2022. The first amendment to the Contract (R2020-1631), dated November 17, 2020, extended the expiration date from December 2, 2020 to December 2, 2021 and increased the contract amount from \$1,000,000 to \$3,000,000. The increased contract amount is based on updated estimates that exceed the current contract amount to be expended throughout Palm Beach County (County). On August 9, 2021, the Office of Equal Business Opportunity (OEBO) approved the renewal of the contract under the current terms because the current Small Minority Women Business Enterprise (S/M/WBE) participation is satisfactory based upon the availability of S/M/WBEs certified to perform the work. To date, tasks in the amount of \$761,841.80 have been authorized for this Contract. The Affirmative Procurement Initiative selected for this Contract on April 3, 2019 by the Goal Setting Committee is a 20% minimum mandatory Small Business Enterprise (SBE) participation. RDP agreed to 61% SBE participation. RDP is a Palm Beach County based SBE certified company. After this renewal, the contract will be resolicited. <u>Countywide</u> (YBH)

Background and Justification: The increase in the amount of the Contract is based upon the estimated amounts to be expended for small paving and minor construction projects throughout the County on a task order basis. After reviewing Amendment No. 2 and finding it to be in proper order, the Engineering Department recommends approval by the Board of County Commissioners.

- 3. The ANNUAL CONTRACT is hereby amended to increase the amount by \$100,000, from \$3,000,000 to \$3,100,000.

Except as hereby amended, changed or modified, all other provisions of the ANNUAL CONTRACT as amended, shall remain in full force and effect.
