#### I. EXECUTIVE BRIEF

**Motion & Title: Staff recommends motion to approve:** the appointment of Darnell Gardner to the Impact Fee Review Committee at-large seat seven (7) to complete the unexpired term of Stewart W. Bosley, Jr., which ends April 19, 2024.

**Summary:** The Impact Fee Review Committee is composed of seven (7) members and three (3) alternate members. The voting membership of the IFRC shall include three (3) representatives from municipalities within PBC, three (3) representatives from the business community, and one (1) member selected at-large. The alternate members shall include one (1) representative from each of the three (3) categories listed above. This agenda item provides for the appointment of Darnell Gardner to at-large seat seven (7) to complete the unexpired term of Mr. Stewart W. Bosley, Jr., which ends April 19, 2024. Darnell Gardner has completed the required ethics training. The Committee has seven seats. Six seats are currently filled and the current diversity count for the committee is Caucasians: 5 (83.33%), African American: 1 (16.67%). The male to female gender ratio is 5:1. This nominee is an African American male. Countywide (RPB)

**Background and Justification:** Article 2 of the ULDC provides for an Impact Fee Review Committee. The Committee has the following powers and duties under the provision of the Code:

- 1. Submit a report to the BCC whenever PBC conducts a full review or update of the impact fee system.
- 2. Review amendments to Article 13, Impact Fees.
- 3. Perform such other duties as the BCC deems appropriate.

This agenda item provides for the appointment of Darnell Gardner to fulfill the unexpired term of Stewart W. Bosley, Jr., who resigned from the at-large seat seven (7) of the Impact Fee Review Committee on August 4, 2021.

#### Darnell Gardener

#### Biography

"We are all trying to live the American dream," declares Darnell Gardener, "You don't have to go to college to make it. Find your passion. Find out what makes you happy and put your heart into it." This sage advice is what this successful serial entrepreneur and real estate businessman would have given to his younger self and freely shares with anyone willing to learn the secrets to his success. It is his mission in life to not leave this earth without sharing all the knowledge he has gained.

As a real estate, mortgage broker, and general contractor, Darnell Gardener currently sits at the helm of 1st Source, LLC, a brand that covers the real-estate, mortgage, and construction markets in Florida, Georgia, and the Caribbean. Licensed in all three regions, he and his team of professionals are able to provide seamless local and international service as a one-stop shop for real estate, mortgages, and construction.

Born in Baltimore, Maryland into a military family, Darnell moved around a lot for most of his childhood, living in Germany, Panama, Oklahoma, and Arizona. While he never stayed in any place long enough to develop life-long childhood friends, the benefits were far greater. He counted the richness of his experiences through travel and meeting new people as priceless, along with the discipline of being raised by a military father. This was reinforced in high school as member of the JROTC and the football team.

It was at Kemper Junior Military College while earning an associate degree, that Darnell internalized the discipline of a routine that he believes made him the man he is today. Just as every day followed a specific routine at the military academy, he carries himself in the same manner today, following strict discipline and protocols in his business.

Darnell was always self-aware and knew what his strengths were. He knew that he was a good communicator and that he was good at sales. He majored in communications and media studies at Robert Morris University in Pennsylvania. It was his first entry-level position after college that discouraged him from working for corporate America after he found out that someone else at his job with less education made more money than he did.

He moved on and found success quickly in sales at a major tobacco corporation where he dominated his territory within his first year. As much as this confirmed what he already knew about his sales abilities, he found no joy in the knowledge that the product he was promoting was dangerous. Thus, he followed his conscience and walked away.

This was a pivotal shift in Darnell's life as he decided to move south to Florida with entrepreneurial dreams. His first venture was a medical staffing company for respiratory therapists in Broward County. This business did spectacularly well. However, he was not passionate about it.

One day, he met a lady who did mortgages, and he became interested in learning to do what she did. He took a class and became licensed and was guided by a broker on the business. He knew that he found what he was truly passionate about because he gave it his all. In 2004, he opened his first one-stop shop for mortgages and real estate in Tamarac, a business that has grown into the 1st Source brand that exists today, operating out of three offices.

His vision for 1st Source is to open more offices and to help People of Color to understand how to transact, own, and become landlords. #### 3. Board Membership

#### a. Qualifications

There shall be nine members of the HRRB. Members of the HRRB shall be residents of PBC, Florida and demonstrate an interest in local history. One member with professional experience shall be appointed from each of the following five professional disciplines: history, architecture, archeology, architectural history and historic architecture. Other historic preservation related disciplines, such as Urban Planning, American Studies, American Civilization, Cultural Geography or Cultural Anthropology shall be considered when choosing appointments for these five of the nine members of the HRRB. Each of these five positions shall meet the requirements outlined in the Professional Qualifications Standards of the Florida Certified Local Government Guidelines. In addition to the above five positions, there shall be a sixth person with a demonstrated interest, degree or experience in one of the above professional disciplines who is also a resident of the area of PBC West of Twenty Mile Bend, including any of the incorporated or unincorporated communities in proximity to Lake Okeechobee. There are no specific requirements for the other three positions as a prerequisite to appointment but consideration shall be given to the following with a demonstrated interest in history, architecture or related disciplines: business person, engineer, contractor in a construction trade, landscape architect, urban planner, attorney, and resident of areas identified by 1990 PBC Historic Sites Survey as containing 25 or more structures with potential for historic preservation. Persons seeking appointment to the HRRB shall be willing to invest time to assist staff in site evaluations, establishing priorities, public education efforts, survey and planning activities of the Certified Local Government Program and the other responsibilities of the HRRB. Board members shall attend pertinent educational conferences and seminars.

#### b. Appointment

The members of the HRRB shall be appointed at-large by the BCC.

#### Terms of Office

Each appointment shall be made for a term of three years. Any member may be reappointed upon approval of the BCC as provided for herein. [Ord. 2013-001]

#### 4. Secretary and Staff

#### Secretary

The Planning Director of the PZB shall serve as Secretary to the HRRB.

#### Staff

The Planning Division shall be the professional staff of the HRRB. The Board shall make every effort to minimize demands on staffing in consideration of budgetary constraints.

#### 5. Meetings

#### a. General

General meetings of the HRRB shall be held at least four times per year. Special meetings may be called by the Chair of the HRRB, or in writing by a majority of the members of the Board. Staff shall provide 24-hour written notice to each Board member prior to a special meeting. [Ord. 2020-001]

#### Quorum

The presence of a majority of the appointed members of the HRRB shall constitute a quorum necessary to take action and transact business. [Ord. 2020-001]

#### Impact Fee Review Committee

#### 1. Establishment

There is hereby created an Impact Fee Review Committee (IFRC).

#### 2. Powers and Duties

The IFRC shall have the following powers and duties under the provisions of this Code:

- submit a Report to the BCC whenever PBC conducts a full review or update of the impact fee system relating to:
  - 1) the implementation of Art. 13, Impact Fees;
  - 2) actual levels of service for the impact fees exacted in Art. 13, Impact Fees;
  - 3) the collection, encumbrance, and expenditure of all impact fees collected pursuant to Art. 13.
  - the validity and assumptions in the technical memoranda used to support the impact fee schedules in Art. 13, Impact Fees; and,
  - 5) any recommended amendment to Art. 13, Impact Fees.
- b. review amendments to Art. 13, Impact Fees prior to their consideration by the BCC; and,
- perform such other duties as the BCC deems appropriate.

#### 3. Board Membership

#### a. Qualifications

The IFRC shall be composed of seven members and three alternate members appointed by the BCC. The membership of the IFRC shall include three representatives from municipalities within PBC, three representatives from the business community, and one member selected at-large. The voting membership of the IFRC shall include three representatives from municipalities within PBC three representatives from the business community, and one member selected at-large. The alternate members shall include one representative from each of the three categories above. An alternate member shall be authorized to vote in place of an absent voting member appointed from the same category and shall count toward a quorum.

#### 4. Officers

#### a. Secretary

The Impact Fee Coordinator shall serve as Secretary of the IFRC.

#### 5. Meetings

#### a. General or Special Meetings

General meetings of the IFRC shall be held as needed consistent with its powers and duties. Special meetings may be called by the Chair of the IFRC, or in writing by a majority of appointed members of the IFRC. 24-hour written notice shall be given to each IFRC member for a special meeting.

#### 6. Term Limits

Beginning on or after March 2, 2013, no person shall be appointed or reappointed to this Board for more than three consecutive terms. **[Ord. 2014-001]** 

#### J. Planning Commission

#### 1. Establishment

There is hereby established a Planning Commission (PLC). [Ord. 2008-003]

#### 2. Powers and Duties

- a. to serve as the Local Planning Agency (LPA) per <u>F.S. § 163.3174</u>, and to provide recommendations on the preparation of the Plan, or any element or portion thereof, and any text amendments thereto to the BCC:
- b. to initiate, review, hear, consider, and make recommendations to the BCC to approve, approve with conditions, approve with modifications, or deny applications to amend the Plan, including Site Specific (Future Land Use Map) amendments to the Plan; [Ord. 2018-002] [Ord. 2018-002]
- to make its special knowledge and expertise available upon written request and authorization of the BCC to any official, department, board, commission or agency of PBC, the State of Florida or Federal Governments;
- d. to make additional or amended rules of procedure not inconsistent with this Section to govern the PLC's proceedings; [Ord. 2008-003]
- e. to make studies of the resources, possibilities and needs of PBC and to report its findings and recommendations, with reference thereto, from time to time, to the BCC;
- f. to submit an Annual Report to the BCC summarizing its annual activities; and,
- g. to review and make recommendations to the BCC on Transportation Concurrency Management Area (TCMA) and Constrained Road at Lower Levels of Service (CRALLS) or a major thoroughfare on which a lower LOS is set pursuant to <a href="Art.12">Art. 12</a>, <a href="Traffic Performance Standards">Traffic Performance Standards</a>.

#### 3. Board Membership

#### a. BCC Appointed Members

The PLC shall be comprised of 16 members; 15 BCC appointed members and one representative of the School District of PBC. **[Ord. 2008-003]** 

#### 1) Qualifications

Although no specific experience requirements shall be necessary as a prerequisite to appointment, consideration shall be given to Applicants who have experience or education in planning, law, architecture, natural resource management, real estate, and related fields.

#### 2) Appointment

Although no specific experience requirements shall be necessary as a prerequisite to appointment, consideration shall be given to Applicants who have experience or education in planning, law, architecture, natural resource management, real estate, and related fields.

ITEM: The purpose of this memo is to request your support for the replacement and nomination of one new committee member to the Impact Fee Review Committee (IFRC). On April 20, 2021, Mr. Stewart Bosley, Jr. was approved and appointed to serve on the IFRC in seat 7 for three years; however, on August 4, 2021, Mr. Bosley submitted his request and notification to withdraw from serving on the committee. The new nominee to replace Mr. Bosley is Mr. Darnell Gardener. If approved, Mr. Gardener will replace and complete Mr. Bosley's three year term on the committee. The term is from April 20, 2021 through April 19, 2024.

BACKGROUND: Article 2 of the ULDC provides for an Impact Fee Review Committee. The Impact Fee Review Committee is composed of seven members and three alternate members. The voting membership of the IFRC shall include three representatives from municipalities within PBC, three representatives from the business community, and one member selected at-large. The alternate members shall include one representative from each of the three categories listed above. The Committee has the following powers and duties under the provision of the Code:

- 1. Submit a report to the BCC whenever PBC conducts a full review or update of the impact fee system.
- 2. Review amendments to Article 13, Impact Fees.
- 3. Perform such other duties as the BCC deems appropriate.

The nominee has completed the required ethics training. This Committee has seven seats. Six seats are currently filled and the current diversity count for the committee is Caucasians: 5 (83.33%), African American: 1 (16.67%). The male to female gender ratio is 5:1.
