The County has expended or encumbered \$199,374 (\$26,583/month) during the previous seven and one half (7.5) months of the current twelve (12) month term contract. The Water Utilities Department requests an increase of \$225,001 over the previous authorized amount of \$199,999 for the remaining four and one half (4.5) months of the current term contract. This increase is necessary due to the unexpected hauling of raw sewage from the lift stations at Torry Island due to force-main break and unanticipated services needed due to the upcoming rainy season. The contract amount for the: (i) initial twelve (12) month term was \$138,000 with \$4,958 expended; (ii) first twelve (12) month renewal term was \$138,000 with \$89,368 expended; and (iv) third twelve (12) month renewal term was \$138,000, which was increased to \$199,999. The Water Utilities Department requests the approval of negotiated terms between Palm Beach County and ARCOS LLC for Term Contract #SS300612, for ARCOS LLC, RosterApps Software, Implementation, Training, and Annual Maintenance and ARCOS LLC Rosterapps Software License Fee. In accordance with PPM CW-F-049, the Department of Risk Management and the County Attorney's Office, following negotiations with the County agree to a limitation of liability provision that deviates from the County's standard. The agreement with ARCOS contains a bilateral waiver for certain indirect damages and loss or damage to the County's systems. In addition, the agreement limits ARCOS' maximum aggregate liability to the fees paid to ARCOS for the most recent twelve (12) month period of the agreement. This limitation of liability does not apply to: (a) third party claims for death, personal injury, or property damage for which ARCOS is held liable by a court of competent jurisdiction and a final, non-appealable order is entered that states as such; and (b) ARCOS's obligation to indemnify the County, both under the County's standard indemnification provision, and for intellectual property issues. In addition, the standard County indemnification language was modified to: (a) remove ARCOS's obligation to indemnify the County to the extent caused by the County's negligence or willful misconduct; and (b) only apply to ARCOS' negligent or willful bad act or omissions. These negotiated terms between Palm Beach County and ARCOS LLC will be used for future sole source purchases and services, as applicable. This term contract has two (2) twelve (12) month renewal options. Awardee is located out of State. This is a sole source provider who is not a certified S/M/WBE. This sole source contract is exempt from the EBO Ordinance.
