I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to: A) Receive and File: Grant Modification 1 with the Office of National Drug Control Policy to provide an additional \$34,064 in grant funds for the Palm Beach County Sheriff's Office; **B) Approve** a budget amendment of \$34,064 in the Sheriff's Grant Fund.

Summary: On April 6, 2021, the Palm Beach County Sheriff's Office (PBSO) received a grant award from the Office of National Drug Control Policy (ONDCP) in the amount of \$132,496 for the period of January 1, 2021 through December 31, 2022 (R-2021-0456). This Grant Modification #1 will provide an additional \$34,064 in grant funding to support overtime for the Palm Beach County Narcotics Task Force. The Catalog of Federal Domestic Assistance (CFDA) number is 95.001 and the contract number is G21MI0011A. There is no match requirement associated with this award. Countywide (LDC)

Background and Justification: The HIDTA mission is to reduce drug availability by creating and supporting intelligence-driven task forces aimed at eliminating or reducing domestic drug trafficking and its harmful consequences through enhancement and coordination of drug trafficking control efforts among federal, state and local law enforcement agencies.
