I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve:

A) Amendment No. 1 to the contract with D. Stephenson Construction, Inc. (R2020-1576) establishing a Guaranteed Maximum Price (GMP) for construction management services for the Homeless Resource Center 2 (HRC2) project located at 3680 Lake Worth Road, Lake Worth in the amount of \$14,064,641 for a period of 420 calendar days from notice to proceed; and

B) Irrevocable Letter of Direction submitted by D. Stephenson Construction, Inc. dated February 17, 2022 and requested by its surety directing the establishment of an escrow account for the project.

Summary: On October 20, 2020, the Board of County Commissioners (Board) approved the contract with D. Stephenson Construction, Inc. (DSC) for the HRC2 project and Task Order No. 1 (R2020-1577) for preconstruction services in the amount of \$57,800. The project provides for the construction of a new facility to include 60 new emergency shelter (interim housing) beds, 14 transitional beds, a welcome center, office areas, outdoor facilities, specialized storage, a Palm Beach Sheriff's Substation, a healthcare facility and support facilities (kitchen, laundry, pantry, community room, shower/rest rooms, cleansing room). Preconstruction services include validating constructability, cost estimating, and procurement services. Amendment No. 1 authorizes the construction of the HRC2 facility including all site work, landscaping, associated culvert canal crossing work, a new entrance on Lake Worth Road, the closure and restoration of the existing entrance on Gulfstream Road and the reconfiguration of the area affected by the construction of the entrance on Lake Worth Road. The Contractor will have 420 calendar days from permit issuance to substantially complete the project. Liquidated damages for failure to achieve certification of substantial completion within the contract time or approved time extension thereof are \$178 per day. The surety bonding the project, Atlantic Specialty Insurance Group (a subsidiary of Intact Insurance Group USA, LLC) has requested that DSC issue an Irrevocable Letter of Direction to the County for the establishment of a project dedicated escrow account. The Irrevocable Letter of Direction is a funds management tool not commonly used by the County in its construction projects. After receiving the Irrevocable Letter of Direction, Staff conducted additional due diligence to fully understand the operational and financial implications of recommending approval; no detrimental impacts were identified. Therefore, Staff is recommending approval of the Irrevocable Letter of Direction. (Continued on Page 3.)

Summary Cont'd:

The CM was selected through a competitive solicitation in accordance with the federal requirements provided by the Department of Housing and Economic Development (DHED). Under the federal requirements, this project has a 22.4% minority and 6.9% female Equal Employment Opportunity (EEO) participation goal. The EEO minority participation for Amendment No. 1 is 22.4% including 6.9% female participation. D. Stephenson Construction, Inc. is a Palm Beach County business. The funding sources for this project include the Infrastructure Sales Tax fund (IST) and Community Development Block Grant (CDBG). (Capital Improvements Division) District 3 (MWJ)

Background and Justification: CM at Risk is a project delivery method where the CM provides design phase assistance, evaluation of cost, schedule and implications of alternate designs, systems and materials, and serves as the general contractor bidding the subcontracts for construction.

The mission of the HRC2 facility is to provide an effective crisis response system that provides immediate and easy access to safe and decent shelter to anyone that needs it, and aims to re-house people as quickly as possible. In order to meet the Community Service Department's mission and operational requirements, a new homeless resource center is to be constructed at 3680 Lake Worth Road, Lake Worth, which is in the south central region of the County. Final selection for construction manager at risk services for the Homeless Resource Center 2 project was completed on August 4, 2020.

The project cost for the HRC2 facility was estimated at \$8.3 million; on January 4, 2022, the Board approved the re-estimated Infrastructure Surtax (IST) project plan with a revised total project cost estimate of \$17.6M for the HRC2 project, of which \$14,943,697 is allocated from the IST plan. The project cost estimate includes design services, construction administration services, construction management services, construction costs, contingency, testing, special inspections, permit fees, and furnishings. Funding sources for this project include the infrastructure surtax fund (IST), Community Development Block Grant (CDBG) and Ad Valorem funds. A Memorandum of Understanding was executed between the DHES and the Facilities Development and Operations Department (FDO) in order to complete the project.

AMENDMENT # 1 D. STEPHENSON CONSTRUCTION, INC. TO CONTRACT FOR CONSTRUCTION MANAGEMENT AT RISK SERVICES HOMELESS RESOURCE CENTER 2 (HRC2) PROJECT NO.: 19220 FEDERALLY FUNDED

This Amendment is made as of ______ by and between Palm Beach County, a political subdivision of the State of Florida, hereinafter referred to as Owner, and D. Stephenson Construction, Inc., hereinafter referred to as "Construction Manager".

WHEREAS, the Owner and Construction Manager acknowledge and agree that the Contract between Owner and Construction Manager dated October 20, 2020 (R2020-1576) (hereinafter the Contract) is in full force and effect and that this Amendment incorporates all the terms and conditions of the Contract including the Federal Requirements as may be supplemented and amended by this Amendment.

WHEREAS, the parties have now established a Guaranteed Maximum Price for the Project, including the Construction Manager's fees calculated in accordance with the Construction Manager's Price Proposal attached to the Contract, whereby the Construction Manager will render construction and warranty services and other services as set forth herein and in the Contract;

NOW THEREFORE, in exchange for the mutual covenants and promises set forth herein and the sums of money agreed to be paid by the Owner to the Construction Manager, the parties agree as follows:

1. Recitals. The foregoing recitals are true and correct and incorporated herein by reference.

2. Construction Manager's Representations. The Construction Manager represents that:

The Construction Manager, Trade Contractors, Sub-subcontractors, material and equipment suppliers have compared Phasing, Demolition, Architectural, Structural, Mechanical, Electrical, Plumbing, Civil and Site Drawings and Specifications and have compared and reviewed all general and specific details on the Drawings and that all conflicts, discrepancies, errors and omissions, which are within the commonly accepted knowledge based of a licensed general contractor, subcontractor, trades persons, manufacturers or other parties required to carry out the Work involved in this Amendment, have been corrected or clarified prior to execution of this GMP Amendment to the Contract, and therefore Construction Manager warrants that the GMP (exclusive of contingency) includes the cost of correcting all conflicts, discrepancies, errors, or omissions which Construction Manager identifies, or should have identified through the exercise of reasonable skill and care, during the preconstruction phase of this Project.

The Construction Manager's review and comparison of all Drawings has taken into consideration the total and complete functioning of all systems and therefore the Construction Manager represents that the GMP represents the total cost for complete and functional systems.

3. Federal Requirements. Construction Manager reaffirms, certifies, represents and warrants that it will continue to comply with all Federal Requirements as set forth in the Contract.

4. EEO Goal. EEO goals of 22.4% Minority and 6.9% Female participation have been established for this Project. Construction Manager anticipates an EEO utilization of <u>22.4</u>% Minority participation and <u>6.9</u>% Female in this construction phase.

5. Wage Rates: The Construction Manager agrees to comply with Davis-Bacon and Copeland Act requirements found at 40 USC 3141 et seq and 18 USC 874. The Davis Bacon Wage Determination is attached hereto and incorporated herein as **Exhibit "B"**.

6. Guaranteed Maximum Price. Pursuant to Section 2.2 and Article 6 of the Contract between Owner and Construction Manager, the parties have agreed to a Guaranteed Maximum Price of \$14,064,641 for the construction phase of the Project. The GMP is based on the following: Exhibit A. In the event of a conflict between the terms and conditions of the Contract and the terms and conditions of Construction Manager's GMP proposal, the terms and conditions of the Contract shall control.

7. Schedule of Time for Completion. The time of completion for this Amendment will be as follows: The Construction Manager shall substantially complete the work within 420 calendar days from the Notice to Proceed from Owner. Liquidated Damages are \$178/day for failure to achieve certification of Substantial Completion within the contract time or approved extension thereof.

83.1 Construction Manager warrants and represents that it is in compliance with section 448.095, Florida Statutes, as may be amended, and that it: (1) is registered with the E-Verify System (E-Verify.gov), and beginning January 1, 2021, uses the E-Verify System to electronically verify

the employment eligibility of all newly hired workers; and (2) has verified that all of the Contractor's trade contractors and subcontractors performing any duties and obligations under this Contract are registered with the E-Verify System and beginning January 1, 2021 use the E-Verify System to electronically verify the employment eligibility of all newly hired workers.

83.2 Construction Manager shall obtain from each of its trade contractors and subcontractors an affidavit stating that the trade subcontractor or subcontractor does not employ, contract with, or subcontract with an Unauthorized Alien, as that term is defined in section 448.095(1)(k), Florida Statutes, as may be amended. Construction Manager shall maintain a copy of any such affidavit from a trade contractor or subcontractor for, at a minimum, the duration of the subcontract and any extension thereof. This provision shall not supersede any provision of this Contract which requires a longer retention period.

83.3 Owner shall terminate this Contract if it has a good faith belief that Construction Manager has knowingly violated Section 448.09(1), Florida Statutes as may be amended.

83.3.1 If Owner has a good faith belief that Construction Manager's trade contractor or subcontractor has knowingly violated Section 448.09(1), Florida Statutes, as may be amended, Owner shall notify Construction Manager to terminate its contract with the trade contractor or subcontractor and Construction Manager shall immediately terminate its contract with the trade contract with the trade contractor.

83.4 If Owner terminates this Contract pursuant to the above, Construction Manager shall be barred from being awarded a future contract by Owner for a period of one (1) year from the date on which this Contract was terminated. In the event of such contract termination, Construction Manager shall also be liable for any additional costs incurred by Owner as a result of the termination.

9. Except as specifically modified herein, the Contract remains in full force and effect. All capitalized terms herein shall have the same meaning as set forth in the Contract.

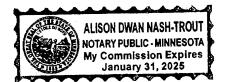

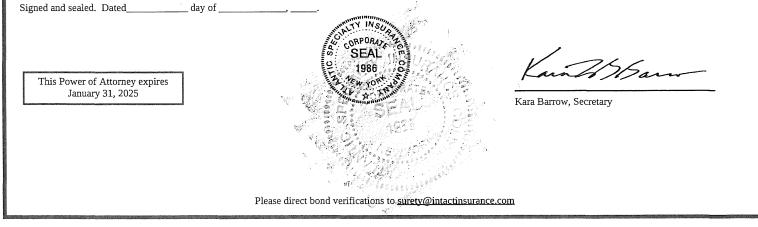
