The County has expended or encumbered \$0 (\$0/month) during the previous one quarter (0.25) months of the current twelve (12) month term contract. An increase of \$200,001 over the previous authorized amount of \$199,999 is requested for the remaining eleven and three quarter (11.75) months of the current term contract. Due to the urgent nature of this contract and an impending gap in service, this contract was approved by the Purchasing Director in the amount of \$199,999, and now requires Board approval of an increase to allocate to Fire Rescue the anticipated expenditure amount initially requested for the contract term. This term contract has four (4) twelve (12) month renewal options. Awardee is located outside Palm Beach County in the City of Hollywood, Florida. The Goal Setting Committee recommended an SBE Price Preference for this solicitation. No S/MWBE vendor bid within 10% of the low bidder.

The County has expended or encumbered \$304,256 (\$9,659/month) during the previous thirty-one and one half (31.5) months of the current thirty-six (36) month term contract. This revenue generating contract has generated \$6,746,378 (\$214,170/month) in revenue during the previous thirty-one and one half (31.5) months of the current thirty-six (36) month term contract. It is anticipated that this revenue generating contract will generate \$7,000,000 during this twenty-four (24) month renewal term contract, of which the County will pay the Contractor an estimated \$346,000 in fees (6% of the non-Medicaid gross monthly collections and 3% of the Medicaid gross monthly collections). This term contract has no renewal options remaining. Awardee is located out of State. This item was reviewed by the OEBO and a Waiver of API requirements was approved.
