I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to receive and file: Three (3) fully executed Palm Beach County FY2021 Grant Agreements managed by the Palm Beach County Sports Commission, Inc on behalf of the Palm Beach County Tourist Development Council (TDC) with:

- A. Maureen Connolly Brinker Tennis Foundation, Inc., for the promotion of the Little "Mo" Internationals in Florida, held from December 3 8, 2021, for the term August 3, 2021 April 8, 2022. This grantee was approved by the TDC on September 9, 2021, in the amount of \$12,500;
- B. Caribbean Baseball Organization, Inc., for the promotion of the Palm Beach Challenge College & International Baseball Festival, held from March 9-31, 2022, for the term September 9, 2021 June 30, 2022. This grantee was approved by the TDC on December 9, 2021, in the amount of \$15,000; and
- C. Foster Events Group, LLC, for the promotion of the Association of Pickleball Professionals Delray Beach Pickleball Open, held from March 22 27, 2022, for the term September 15, 2021 June 20, 2022. This grantee was approved by the TDC on December 9, 2021, in the amount of \$12,000;

Summary: In accordance with County PPM CW-O-051, all delegated contracts/agreements/grants must be submitted by the initiating Department as a Receive and File agenda item. On June 7, 1994, the Board of County Commissioners adopted resolution (R94-702) authorizing the Executive Director of the Tourist Development Council to enter into grant agreements with Category G (Sports) grantees after they have been approved by the Tourist Development Council. Combined, these agreements generated a total of 9,121 room nights, and also funded events which promoted sports tourism in Palm Beach County. <u>Districts 1,2,7</u> (YH)

Background and Justification: The Sports Commission Agreement (Resolution 94-207) was adopted by the Board to streamline the process of promoting, marketing, and increasing sports tourism to Palm Beach County. The Board granted the Director of the Tourist Development Council authority to execute Category G Agreements. The grant agreement has been executed on behalf of the Board by the Executive Director of the Tourist Development Council in accordance with the authority delegated by the Board and is now being submitted to the Board to receive and file.
