I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: a contract with Constructive Engineering, Inc. (Constructive) in the amount of \$545,390.60 for Miner Road from Military Trail to Lawrence Road (Project).

SUMMARY: Approval of this contract will authorize the professional services necessary for preparation of design plans and construction bid documents for a new three-lane roadway. While the right of way exists for Miner Road from Military Trail to Lawrence Road, the roadway is not constructed to Palm Beach County (County) standards within this segment. The Affirmative Procurement Initiatives selected for this contract on May 15, 2019 by the Goal Setting Committee are a 20% minimum mandatory Small Business Enterprise (SBE) participation and an SBE Evaluation Preference for Prime respondents. Constructive agreed to 80% SBE participation for the contract. Constructive has an office located in the County and is a certified SBE company. On September 7, 2021, the Consultant's Competitive Negotiations Act Selection Committee selected Constructive and, in accordance with PPM No. CW-O-048, the Board of County Commissioners (BCC) was notified of the selection on September 8, 2021. This Project is included in the Five-Year Road Program. District 2 (YBH)

Background and Justification: The County is now contracting with Constructive to provide professional services necessary for the Project. The fee, as detailed in Exhibit B of the attached contract, has been negotiated as just and reasonable compensation as follows:
