## I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: payment in the amount of \$3,000 for participation in the 16<sup>th</sup> Annual Palm Beach Partners Business Matchmaker Conference & Expo, which will be held on October 27, 2022.

Summary: The Palm Beach County Office of Equal Business Opportunity, Department of Airports, and Palm Tran are partnering with the South Florida Water Management District (SFWMD), the School District of Palm Beach County, the City of West Palm Beach, the Center for Technology, Enterprise & Development, Inc. (TED Center), and the Solid Waste Authority (SWA) to present the 2022 Business Matchmaker Conference & Expo (a statewide conference). This is the 16th Annual Matchmaker Conference & Expo held in Palm Beach County, and Palm Beach County will contribute a total of \$3,000 with the County's contribution broken down as follows: the Office of Equal Business Opportunity - \$1,000, Department of Airports - \$1,000, and Palm Tran - \$1,000. Payment will be made on or before July 1, 2022, to the TED Center, the fiscal agent for the conference. The conference and expo will provide Small Business Enterprise owners an opportunity to collaborate with larger businesses in an effort to increase business opportunities and knowledge of programs offered by the above listed governmental and non-profit partners. Background and Justification: On October 27, 2022, the Palm Beach Partners will present the 16th Annual 2022 Business Matchmaker Conference & Expo at the Palm Beach Convention This event will feature workshops and seminars that will provide information to Center. Additionally, one-on-one business matchmaking appointments will be made available for conference participants to meet with key staff from Palm Beach County, the SFWMD, School District of Palm Beach County, the City of West Palm Beach, the TED Center, and the SWA.
