Summary: On March 7, 2022, the Youth Services Department issued a Notice of Funding Opportunity (NOFO) for Community Based Agencies (CBA) funding for three (3) years, beginning in FY2023. Proposals were accepted for three (3) action areas identified as a priority in the Youth Master Plan (YMP): Health and Wellness, Ensure Safety and Justice, and Social and Emotional Learning Supports. To continue to align programs with the YMP and incorporate evidence-based/promising programming with outcomes and performance measures, the NOFO was issued. Final contracts with each Action Area Agency will be presented to the Board after contract negotiations are complete. Countywide (HH) Continued on Page 3

Background and Policy Issues: The NOFO was issued for three (3) Action Areas. The proposed contract awards under this NOFO total \$2,208,000, annually for three (3) years. The Board approved a Contract with Forum for Youth Investment Corp. on December 15, 2015, for the creation of a collaborative YMP, which was published in November 2016 and presented to the Board in a workshop on January 24, 2017, along with the recommended funding areas. The YMP identified six (6) priority areas. For FY2023, three (3) Action Areas were selected for funding pursuant to the issuance of the NOFO. The Health and Wellness Action Area ensures access to healthy foods and exercise options and addresses youth physical and mental health risks/issues. The Ensure Safety and Justice Action Area provides intervention and alternatives to crime, and strengthens prevention efforts to deter entry into the delinquency system. The Social and Emotional Learning Supports Action Area focuses on activities and supports through quality outof-school time programs. A total of thirty-five (35) proposals were received. The proposals were initially reviewed for responsiveness. Two proposals were deemed non-responsive due to failure to submit required documentation. Proposals meeting minimum requirements were reviewed by a separate Review Panel for each Action Area, and consisted of community experts. The Review Panels scored the proposals based on the following criteria: Description of Need, Local Data, Approach and Design, Evaluation Methods, Performance History, Available Resources and Sustainability, and Budget. The Review Panels also ranked proposals based on the priority and criticality of the services in the community. The YSD Director made the final recommendations utilizing each Review Panel's scoring and ranking, knowledge of other funding availability and a review of budget needs and available resources.

Pursuant to previous Board direction, a protest process was included with this NOFO. One protest was filed by M&S Community Stars of Performing Arts and Academics regarding required documentation and the determination of non-responsiveness was upheld. Another protest was filed by Gulfstream Goodwill Industries regarding their Going the Distance Mentoring Program on the basis of scoring. All agencies were advised that scoring would not be the sole determining factor. A mentoring program is in place through the Enhanced Mentoring program jointly funded by Palm Beach County and the Children's Services Council that will be able to serve those youth in the juvenile justice system. The protest is denied. Gulfstream Goodwill Industries is being recommended for funding for the Intensive Home Detention Program which is the only one of its kind in Palm Beach County.

BACKGROUND

Youth Symposium and Creation of Birth to 22: United for Brighter Futures

and education of children and youth from prenatal to young adulthood. Birth to 22: United for Brighter Futures (Birth to 22) is the alliance of community partners that emerged from the Youth Symposium. Birth to 22 affirms a whole child approach to this collaborative work. The partners of Birth to 22 agreed that a Youth Master Plan (YMP) was necessary to best guide the collective In 2013, the Board of County Commissioners (BCC) and a group of community organizations and leaders convened the Infant, Child, Youth and Young Adult Symposium (Youth Symposium) to share information and identify actions and programs to support the healthy growth, development community to achieve the best results for Palm Beach County children and youth.

Youth Master Plan - "Strengthening the Steps to Success"

On December 15, 2015, the BCC approved a Contract with The Forum for Youth Investment (FYI) (R2015-1852), which was amended on July 12, 2016 (R2016-0919), to provide professional/consultation services in the development of the YMP for Palm Beach County. YSD, along with the other youth-serving partner agency members of Birth to 22, participated in a collaborative process employing a collective impact framework to develop the YMP entitled "Strengthening the Steps to Success."

The YMP was developed by over sixty (60) members of Birth to 22 as a blueprint for setting priorities and taking action to improve the lives of children and youth in Palm Beach County. The YMP reflected an ongoing effort to engage community members at all levels in building on strengths, aligning ongoing efforts and addressing gaps in order to create a community where all - from birth to 22 - have an opportunity to succeed, reach their full potential and receive the attention necessary to ensure equity when faced with systemic barriers.

Six Action Areas were Social and Emotional Supports, iv) Educational Supports, v) Health and Wellness Supports and vi) Removal of Community Stressors and Systemic Barriers (which included Ensuring Safety and Justice). Since then, YSD has issued Notices of Funding Opportunity for two (2) or more Action Areas annually. Awarded contracts are for three (3) year periods. identified in the YMP: i) Economic Access, ii) Parenting and Role Models, iii) On January 21, 2017, YSD presented the outcome of the YMP to the BCC.

FY2023 NOFO PROCESS

- YSD Director made the final recommendations utilizing each Review Panel's scoring and ranking, knowledge of other funding availability and a review of budget needs and available resources.
- Out of thirty-five (35) proposals received, two (2) proposals were deemed non-responsive and not distributed to the review panels or scored.
 - Pursuant to Board direction, a protest process was included with this NOFO. One protest was filed by M&S Community Stars of Performing Arts and Academics regarding required documentation and the determination of non-responsiveness was upheld. Another protest was filed by Gulfstream Goodwill Industries regarding their Going the Distance Mentoring Program on the basis of scoring. All agencies were advised that scoring would not be the sole determining factor. A mentoring program is in place through the Enhanced Mentoring program jointly funded by Palm Beach County and the Children's Services Council that will be able to serve those youth in the juvenile justice system. The protest is denied.

Gulfstream Goodwill Industries is being recommended for funding for the Intensive Home Detention Program which is the only one of its kind in Palm Beach County.

° Twenty-three (23) programs are being recommended for funding.
