I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to:

- A) approve a contract with R & D Paving, LLC (RDP) in the amount of \$514,885.25 for construction of the Lantana Road and Congress Avenue Intersection Improvements (Project);
- **B)** receive and file an Interlocal Agreement (ILA) with the City of Lake Worth Beach (City) for utility improvements in the amount of \$35,535.50 for the Project; and
- C) approve a budget amendment of \$35,536. in the Transportation Improvement Fund to recognize reimbursement funding from the City and appropriate it to the Project.

SUMMARY: Approval of this contract will authorize the construction services necessary to reconstruct the median on Lantana Road to extend the eastbound to northbound dual left turn lanes at Congress Avenue. Approval of the budget amendment will recognize the reimbursement funding from the City, as agreed to in the ILA, for utility work they requested. The City shall be responsible for operation and maintenance of their utility work upon completion of the Project. The ILA with the City was approved by the County Engineer by way of delegated authority in accordance with Palm Beach County Administrative Code Section 404.00. The ILA is submitted in accordance with Countywide PPM CW-O-051, all delegated contracts, agreements and grants must be submitted by the initiating department as a receive and file as part of the corresponding agenda item. The Affirmative Procurement Initiative selected for this contract on March 3, 2022 by the Goal Setting Committee is a 20% minimum mandatory Small Business Enterprise (SBE) participation. RDP agreed to 82.8% SBE participation. Bids for the contract were received by the Engineering Department on February 22, 2022. RDP was the lowest responsive bidder of three bidders. The contract time for the Project is 180 calendar days. RDP has an office located in Palm Beach County and is a certified SBE company. This Project is included in the Five-Year Road Program. Districts 2 & 3 (YBH)

Background and Justification: After reviewing the attached contract and finding it in proper order, the Engineering Department recommends approval by the Board of County Commissioners.
