Providing mentorship to children of the fallen, honoring the sacrifice of those who've given their all for our freedom, and promoting patriotism and service in our communities since 2012.

Provide a brief summary of program's activities/services to be funded:

Operation 300, a registered 501(c)3 not for profit organization, hosts weekend-long adventure camps for children who have lost their fathers as a result of military service, pairing each child with a father-aged, male mentor who spends the weekend doing things with the children they might have done with their dad. At camp, a member of the St. Lucie County Sheriff's Office K-9 unit visits the camp to provide a K-9 demonstration. The officer gives instruction on and encouragement to the children on how to avoid getting mixed up in all kinds of crime. He also clearly explains the consequences of doing so...including legal, mental, and future life expectations. The officer usually tells a life story of a criminal he personally arrested and the testimony of that criminals poor choices.

What results are you committed to achieving?

Our goal is to ensure that that family members of our fallen service men and women are not forgotten. We seek to honor the memory of these individuals by caring fro their families, promoting patriotism and honoring their sacrifices every day. We hope that our mentorship programs will help fill the gap that has been left by a now absent father. We strive to teach young men and women to be strong, resilient and successful. This is a vulnerable population. The chances of these kids being involved in crime is higher without the core familial infrastructure at home and dealing with tragedy. We believe the time we spend with them encouraging them to stay the narrow course, avoid drugs and crime will help them to be successful in life. Providing them with a mentor who keeps track of them through the year also provides accountability in this area.

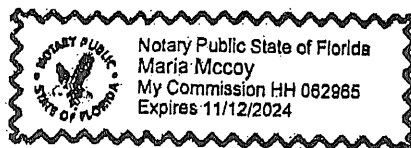

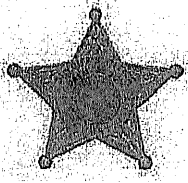

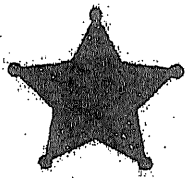

SUFK partners with the 15th Judicial Circuit Guardian ad Litem (GAL) Program to assemble a team that includes an attorney, a child advocate manager, a volunteer child advocate, and 35 GAL Volunteers. This team works side by side throughout the dependency proceedings, following a child during their stay in the foster care system. GALs serve as the eyes, ears and arms of the justice system. They identify the best possible result for each child whose care is now the responsibility of the state. Best interest advocacy! The Guardian Ad Litem Program facilitates moving the child through the system in the shortest time possible. 100% for the child!

The overall goal of Speak Up for Kids is to support the Guardian ad Litem (GAL) Program with the resources to provide every abused, abandoned, and neglected child in the Palm Beach County dependency court system with a well-trained, court-appointed volunteer advocate.
