### I. EXECUTIVE BRIEF

#### Motion and Title: Staff recommends motion to:

- A) approve the Five Year Road Program (Program) Findings of Fact Memo (per Article 12.M.3.B of the Unified Land Development Code) with a majority plus one affirmative vote that the delay of the Florida Mango Road, 10<sup>th</sup> Avenue North to Edgewater Drive (Lake Worth Drainage District L-9 and L-10 Canals, Bridge Replacements) and 60<sup>th</sup> Street N, Avocado Boulevard to east of 120<sup>th</sup> Avenue N, will not result in any link or intersection on the road network operating at greater than the adopted level of service, and no development projects are phased to this construction;
- B) adopt an Ordinance amending Chapter 23, Article 1, Section 23-1(C) of the Palm Beach County (County) Code (Adoption of revised Program); providing for repeal of laws in conflict; providing for a savings clause; providing for severability; providing for inclusion in the code of laws and ordinances; and providing for an effective date; and
- C) approve the hiring of professionals to design, appraise and assist in the acquisition of lands, rights-of-way, and easements necessary to undertake the projects identified in the program, as approved herein, including but not limited to the employment of real estate appraisers, engineers, certified public accountants, business damage consultants and experts, and other professionals deemed necessary.

**SUMMARY:** On June 14, 2022, the Board of County Commissioners (BCC) approved this Ordinance amending Chapter 23, Article 1, Section 23-1(C) on preliminary reading and authorized advertisement for today's Public Hearing for final adoption. Since the development and adoption of the County's program on December 3, 1985, the progress and evolution of current and near term projects have continued to be monitored. Traffic counts, costs and revenues have been updated. The most recent update to the program was on December 7, 2021 (ORD2021-037). Revisions are being proposed to modify the program to reflect this updated information. The Findings of Fact Memo requires a majority plus one affirmative vote for approval.

The approval to hire professionals will facilitate the property acquisitions necessary to accomplish the road goals of the program, as amended herein, for Fiscal Year 2022 through Fiscal Year 2026. <u>Countywide</u> (YBH)

## Background and Policy Issues: (Continued from page 1)

Adoption of this Mid-Year Ordinance to the County's Program is consistent with the BCC's general direction.

The Palm Beach County Five-Year Road Program Ordinance, as amended, allows a semiannual modification of the Five Year Road Program. This Mid-Year adjustment, including **Exhibit "A"**, modifies the Annual Update adopted on December 7, 2021 (ORD2021-037).

Each year since 1987, the BCC has granted approval to appraise and acquire lands, rightsof-way, and easements for projects on the adopted Five Year Road Program during each fiscal year. The Roadway Production Division is again recommending approval to appraise and acquire lands, rights-of-way, and easements, and approval for employment of all professionals and experts, including but not limited to real estate appraisers, engineers, certified public accountants, business damage experts, and other professionals deemed necessary for budgeted projects on the adopted mid-year adjustment, amended herein to the Five Year Road Program that will be undertaken during Fiscal Year 2022 through Fiscal Year 2026. The approval of this item will speed up the lengthy process of acquiring lands, rights-of-way, and easements. Procurement of all professional and expert services and all acquisitions will be in accordance with established County procedures.

## RE: ROAD PROGRAM MID-YEAR ADJUSTMENT PUBLIC HEARING – JULY 2022 FINDINGS OF FACT – CONSTRUCTION DELAYS

Per Article 12.M.3.B of the Unified Land Development Code (ULDC), prior to approving the deletion of any construction project from the Palm Beach County (PBC) Five-Year Road Program, the Board of County Commissioners (BCC) must evaluate two (2) findings of fact.

Article 12.M.3.A of the ULDC defines "deletion of a construction Project" as "the elimination of the construction Project, the failure to let a road construction contract, the removal of or failure to establish funding of the construction Project, the material reduction in the scope of work or funding (as it affects the construction Project), or the postponement of the construction Project in the Five-Year Road Program for more than two years beyond the year the construction was originally programmed". It does not include delays associated with right-of-way acquisition as a result of judicial decision, redesign after the contract has been let, construction, or other delays not under the control of PBC.

To delete any construction project, the BCC must find:

Finding 1: That the deletion of the construction Project will not result in any link or intersection on the road network operating at greater than the Adopted Level of Service (LOS), as defined in Article 12.B.2.C, if such link would not have operated at greater than the Adopted LOS, as defined in this Article, had the Project been constructed as originally programmed in the adopted Five-Year Road Program; and

Finding 2: That no Project, which was approved and phased based upon such Assured Construction, would be denied Building Permits because of the deletion of the construction.

If Finding 1 and Finding 2 can be made, then the construction Project may be eliminated by a majority vote, except if the Project is in the current fiscal year, in which case a majority plus one vote is required.

If only the second finding can be made, then a Project not in the current fiscal year could be deleted by a majority plus one vote.



However, in no case may a Project be deleted when the second finding cannot be made. Note that Article 12.B.2.F.2 of the ULDC also addresses the question of deletion of a construction project from the PBC Five Year Road Program Ordinance to which a Project was approved and phased. This section states that, "Building Permits for development that was phased to that assured construction shall be issued, but not sooner than the end of the fiscal year construction was to commence."

Two (2) Projects in the proposed Mid-Year Update to the Five Year Road Program meet this definition of deletion of a construction project. In order to assist the BCC in making the determination regarding Findings 1 and 2 for these Projects, the following substantial competent evidence has been provided:



## 1. Florida Mango Road, 10th Avenue North to Edgewater Drive:

Construction of improvements for this road was originally scheduled for FY 2020 and is presently scheduled for FY 2022, but is now being delayed to FY 2023. The proposed improvements will replace the existing bridges on Florida Mango Road over the Lake Worth Drainage District (LWDD) L-9 and L-10 Canals, and expand the existing 2 lane segments to 3 lanes. This construction will add capacity to this segment of Florida Mango Road. Construction of the project has been postponed for more than two years beyond the year the construction was originally programmed. Accordingly, for purposes of Article 12.M.3.A, this postponement meets the definition of a "deletion of a construction Project". The delay is due to extending the time required for completion of utility relocations, right-of-way acquisition, and the need to schedule the construction in phases to accommodate the bridge replacement over the LWDD L-8 Canal on Florida Mango Road north of Edgewater Drive. Construction phasing allows the County to maintain traffic flow along Florida Mango Road during construction, by not closing all three bridges (LWDD L-8, L-9, & L-10) at the same time.

### Finding 1

The peak season peak hour volume to capacity ratio for this segment is 0.77, which is better than the adopted LOS D. Because the segment is currently operating within the adopted LOS, Finding 1 is made.

### Finding 2

There are no development projects that are phased to this construction. Finding 2 is made.

Because both Finding 1 and Finding 2 can be made, and the Project is in the current fiscal year, a majority plus one vote is required.



## 2. 60th Street N, Avocado Boulevard to east of 120th Avenue N:

Construction of this segment of 60th Street was originally scheduled for FY 2021 and is presently scheduled for FY 2023, but is now proposed to be delayed to FY 2024. The Project will widen the existing road from 2 lanes to 3 lanes, with 4 foot shoulders and a sidewalk on the south side. This construction will add capacity to this roadway. Construction of the Project has been postponed for more than two years beyond the year the construction was originally programmed. Accordingly, for purposes of Article 12.M.3.A, this postponement meets the definition of a "deletion of a construction Project". The construction delay results from a delay in the design process caused by the design consultant's difficulty in securing the services for specialized investigation by divers of the subaqueous pipe crossing of the M-1 Canal beneath the City of West Palm Beach's M-Canal. This service is necessary to design a safe crossing of 60<sup>th</sup> Street without compromising the M-1 Canal pipe.

#### Finding 1

The peak season peak hour volume to capacity ratio for this segment is 0.03, which is better than the adopted LOS D. Because the segment is currently operating within the adopted LOS, Finding 1 is made.

#### Finding 2

There are no development projects that are phased to this construction. Finding 2 is made.

Because both Finding 1 and Finding 2 can be made, and the Project is not in the current fiscal year, a majority vote is required.

### AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, AMENDING CHAPTER 23, ARTICLE 1, SECTION 23-1(C) (ADOPTION OF REVISED FIVE-YEAR ROAD PROGRAM); PROVIDING FOR REPEAL OF LAWS IN CONFLICT; PROVIDING FOR A SAVINGS CLAUSE; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE OF LAWS AND ORDINANCES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Palm Beach County (County) Code Chapter 23, Article I, Section 23-1, known as the County Five Year Road Program Ordinance (Ordinance), sets forth the road projects in the Five Year Road Program (Program) to be funded, designed and constructed by the County within the next five years; and

WHEREAS, the Board of County Commissioners (BCC) adopted the current Program on December 7, 2021 (Ordinance 2021-037), as provided in Exhibit "A" therein; and

WHEREAS, Section (e) of the Ordinance provides that deletions, substitutions and additions of entire projects from Exhibit "A" may only be accomplished by a BCC Ordinance, and that deletions of projects may be accomplished no more frequently than twice a year; and

WHEREAS, the BCC has considered the funding and timing of road projects for the next five years as set forth in Exhibit "A" to Ordinance 2021-037, and desires to repeal and replace Exhibit "A" of Ordinance 2021-037 with the attached Exhibit "A"; and

WHEREAS, the BCC now wishes to amend the Five Year Road Program Ordinance, as set forth below.

# NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

**SECTION I.** Chapter 23, Article I, Section 23-1 (c) of the County Code is hereby amended as follows:

(c) *Adoption of revised Five-Year Road Program*. The list of projects for the Five-Year Road Program set forth in **Exhibit "A"** of Ordinance 2021-037, is deleted and replaced with the attached **Exhibit "A"**, which is incorporated herein, and is hereby adopted as the Five-Year Road Program.

### SECTION II. REPEAL OF LAWS IN CONFLICT

All local laws and ordinances applying to the unincorporated area of the County in conflict with any provision of this Ordinance are hereby repealed to the extent of such conflict.

### SECTION III. SAVINGS CLAUSE

Notwithstanding anything to the contrary, all provisions of Palm Beach County Code Section 23-1, codifying Palm Beach County Ordinance No. 85-40, as amended, are specifically preserved and remain in full force and effect for the limited purpose of enforcing any alleged violations of said Code which occurred prior to its repeal or amendment.

## SECTION IV. SEVERABILITY

If any section, paragraph, sentence, clause, phrase, or word of this Ordinance is for any reason held by the Court to be unconstitutional, inoperative, or void, such holding shall not affect the remainder of this Ordinance.

## SECTION V. INCLUSION IN THE CODE OF LAWS AND ORDINANCES

The provisions of this Ordinance shall become and be made a part of the Code of Laws and Ordinances of Palm Beach County, Florida. The sections of this Ordinance may be renumbered or relettered to accomplish such, and the word "ordinance" may be changed to "section," "article," or any other appropriate word.

### SECTION VI. EFFECTIVE DATE

The provisions of this Ordinance shall become effective upon filing with the Department of State.

### AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, AMENDING CHAPTER 23, ARTICLE 1, SECTION 23-1(C) (ADOPTION OF REVISED FIVE-YEAR ROAD PROGRAM); PROVIDING FOR REPEAL OF LAWS IN CONFLICT; PROVIDING FOR A SAVINGS CLAUSE; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE OF LAWS AND ORDINANCES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Palm Beach County (County) Code Chapter 23, Article I, Section 23-1, known as the County Five Year Road Program Ordinance (Ordinance), sets forth the road projects in the Five Year Road Program (Program) to be funded, designed and constructed by the County within the next five years; and

WHEREAS, the Board of County Commissioners (BCC) adopted the current Program on December 7, 2021 (Ordinance 2021-037), as provided in Exhibit "A" therein; and

WHEREAS, Section (e) of the Ordinance provides that deletions, substitutions and additions of entire projects from Exhibit "A" may only be accomplished by a BCC Ordinance, and that deletions of projects may be accomplished no more frequently than twice a year; and

WHEREAS, the BCC has considered the funding and timing of road projects for the next five years as set forth in Exhibit "A" to Ordinance 2021-037, and desires to repeal and replace Exhibit "A" of Ordinance 2021-037 with the attached Exhibit "A"; and

WHEREAS, the BCC now wishes to amend the Five Year Road Program Ordinance, as set forth below.

# NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

**SECTION I.** Chapter 23, Article I, Section 23-1 (c) of the County Code is hereby amended as follows:

(c) Adoption of revised Five-Year Road Program. The list of projects for the Five-Year Road Program set forth in Exhibit "A" of Resolution R2021-0765, Ordinance 2021-037, is deleted and replaced with the attached Exhibit "A", which is incorporated herein, and is hereby adopted as the Five-Year Road Program.

### SECTION II. REPEAL OF LAWS IN CONFLICT

All local laws and ordinances applying to the unincorporated area of the County in conflict with any provision of this Ordinance are hereby repealed to the extent of such conflict.

### SECTION III. SAVINGS CLAUSE

Notwithstanding anything to the contrary, all provisions of Palm Beach County Code Section 23-1, codifying Palm Beach County Ordinance No. 85-40, as amended, are specifically preserved and remain in full force and effect for the limited purpose of enforcing any alleged violations of said Code which occurred prior to its repeal or amendment.

## SECTION IV. SEVERABILITY

If any section, paragraph, sentence, clause, phrase, or word of this Ordinance is for any reason held by the Court to be unconstitutional, inoperative, or void, such holding shall not affect the remainder of this Ordinance.

## **SECTION V. INCLUSION IN THE CODE OF LAWS AND ORDINANCES**

The provisions of this Ordinance shall become and be made a part of the Code of Laws and Ordinances of Palm Beach County, Florida. The sections of this Ordinance may be renumbered or relettered to accomplish such, and the word "ordinance" may be changed to "section," "article," or any other appropriate word.

### SECTION VI. EFFECTIVE DATE

The provisions of this Ordinance shall become effective upon filing with the Department of State.
