#### I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to approve:** Amendment 001 to Economic Development Services Agreement R2021-1367 with the Business Development Board (BDB) to clarify the distribution of tickets for County participation in key stakeholder events, and; amend the scope of services to include the continuation of the Growth & Infrastructure Task Force.

**Summary:** Amendment 001 will provide for modifications to the Agreement clarifying the recognition provision for the BDB to provide access to stakeholder events on the County's behalf pursuant to the Agreement, and to revise the scope of services to include the BDB's continuation of the Growth & Infrastructure Task Force to encourage discussions regarding housing, transportation and education. <u>Countywide</u> (HJF)

Background and Justification: The public/private partnership between the County and the BDB works toward creating a stable and diverse economic climate throughout Palm Beach County. Since 1982, the Board of County Commissioners (BCC) has partially funded activities of the Business Development Board of Palm Beach County, Inc. providing for economic and business development activities. On October 1, 2021, the BCC entered into a five (5) year Agreement with the BDB to provide business recruitment, expansion, and retention services and general marketing for Palm Beach County. The BDB is currently on target to meet Fiscal Year 2022/2023 Agreement deliverables.
