#### I. EXECUTIVE BRIEF

## Motion and Title: Staff recommends motion to:

- A) Receive and File an Amendment Memo to the U.S. Department of Homeland Security Federal Emergency Management Agency ("FEMA"), FY2020 Assistance to Firefighters Grant ("AFG") Program COVID-19 Supplemental ("AFG-S") Agreement No. EMW-2020-FG-00759 extending the performance period from June 23, 2021 to June 23, 2022, and;
- **B) Approve** a Budget Amendment of \$43,172 within the Fire/Rescue MSTU Fund to reestablish the carry forward and 10% match amount with the extended end date.

**Summary**: On July 14, 2020 (R2020-0870), the Board accepted an AFG grant award from FEMA for a period of June 24, 2020 through June 23, 2021. The Grant Agreement contemplated that any necessary changes to the award document after an award would be notified to the recipients by FEMA in writing. The Fire Rescue Department received the attached Amendment Memo extending the performance period. This Amendment Memo is now being submitted to the Board to receive and file. **Countywide** (SB)

**Background and Justification:** The AFG grant was accepted for the purchase of PPE and related supplies to prevent, prepare for, and respond to the COVID-19 public health emergency. The FY 2020 AFG-S Program was a supplemental funding opportunity under the AFG. The focus of the AFG Program is to enhance the safety of the public and firefighters with respect to fire and fire-related hazards.
