**Summary:** The Palm Tran Service Board is composed of 13 At-Large members with specific seat categories. There are five (5) board members who are requesting reappointments and four (4) requesting appointment. For Seat 4, the Palm Beach County League of Cities solicited applications in conjunction with Palm Tran and made a formal recommendation to appoint Kashamba Miller-Anderson as the elected municipal official. There are 13 seats comprising the PTSB but only 9 current members. The ethnic and gender composition of the current 9 members include: Caucasian: 3 (30%), African-American: 3 (30%), Hispanic-American: 1 (10%), Multicultural: 1 (10%), Asian American 1 (10%) Gender ratio (male: female) 7:2. **Countywide (MM)**



