I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Work Order No. 22-024 to the annual minor construction contract with Andrea Construction, Inc. (Contractor) (R2020-0143) for the Palm Beach Sheriff's Office (PBSO) K-9- Parking Lot Surface, Canopies and Restroom Renovations project in the amount of \$371,264 for a period of 90 calendar days from permit issuance.

Summary: On February 11, 2020, the Board of County Commissioners (Board) approved the annual minor construction contract with the Contractor to provide construction services associated with repairs, improvements and renovations to County properties. Work Order No. 22-024 includes the installation of three canopies, the addition of asphalt parking and renovation of the existing restrooms to achieve Americans with Disabilities Act (ADA) compliant facilities. This project was competitively advertised, and new contractors were invited to bid on the project by submitting prequalification documents prior to the submission of the bid response. The Contractor will have 90 calendar days from permit issuance to substantially complete the project. Liquidated damages for failure to achieve certification of substantial completion within the contract time or approved time extension thereof are \$80 per day. On August 21, 2019, the Goal Setting Committee applied the following Affirmative Procurement Initiatives (API) for this annual contract: 1) Sheltered market for projects less than \$100,000; or 2) 10% Small Business Enterprises (SBE) Price Preference for single-trade projects \$100,000 or more; or 3) a minimum mandatory 25% SBE subcontracting goal for multi-trade projects. Since this project is a multi-trade project over \$100,000, the applicable API is 25% SBE subcontracting goal. The Contractor is an SBE and committed to 64.66% SBE participation on this work order. The cumulative SBE participation on the annual minor contract is 77.80%. The Contractor is a local business. The funding source for this project is from the Public Building Improvement Fund. (Capital Improvements Division) District 3 (MWJ)

Background and Justification: This project was openly, competitively advertised and procured. Bids for this project were opened on June 16, 2022. Andrea Construction, Inc. submitted the lowest responsive and responsible bid.

THIS WORK ORDER is made as of ______ by and between Palm Beach County, a political subdivision of the State of Florida, by and through its Board of County Commissioners, hereinafter referred to as "Owner", and Andrea Construction, Inc., a Corporation, authorized to do business in the State of Florida, whose Federal ID# is 65-0231292 hereinafter referred to as "Contractor".

WHEREAS, the Owner and Contractor acknowledge and agree that the Contract between Owner and Contractor dated 2/11/20 (R2020-0143) ("Contract") is in full force and effect and that this Work Order incorporates all the terms and conditions of the Contract and the IFB/Q for this project, as may be supplemented and amended by this Work Order;

NOW THEREFORE, in exchange for the mutual covenants and promises set forth herein and the sums of money agreed to be paid by the Owner to the Contractor, the parties agree as follows:

1. Recitals. The foregoing recitals are true and correct and incorporated herein by reference.

2. Total Bid Amount. Pursuant to Section 6.3 of the Instructions to Bidders of the Annual Contract for Minor Construction between Owner and Contractor, the Contractor was the lowest, responsive, responsible Bidder in the amount of \$371,264.00 for the construction costs of installing and repairing three canopies, asphalt area, and restroom renovations as set forth on the Bid Form attached hereto and incorporated herein by reference.

3. Schedule of Time for Completion. The time of completion for this Work Order will be as follows: The Contractor shall substantially complete the project within **90** calendar days of permit issuance. Liquidated Damages are \$80/day for failure to achieve certification of substantial completion within the contract time or approved extension thereof.

4. APIs. The APIs applicable to this Contract are attached hereto.

5. EBO Participation to Date. To date Contractor has achieved 71.44% SBE subcontracting participation on this Contract. Contractor will provide 64.66% on this Work Order.

Terminate this Annual Contract for cause; 4. Suspend or debar the Bidder from bidding on future projects for a period of two (2) years, in accordance with the Palm Beach County Purchasing Ordinance; and/or 5. Pursue any and all remedies available against the Bidder for damages resulting from its failure to enter into a Work Order and provide all required documents within 14 Days after notification.

83.3.1 If Owner has a good faith belief that Contractor's subcontractor has knowingly violated Section 448.09(1), Florida Statutes, as may be amended, Owner shall notify Contractor to terminate its contract with the subcontractor and Contractor shall immediately terminate its contract with the subcontractor.

83.4 If Owner terminates this Contract pursuant to the above, Contractor shall be barred from being awarded a future contract by Owner for a period of one (1) year from the date on which this Contract was terminated. In the event of such contract termination, Contractor shall also be liable for any additional costs incurred by Owner as a result of the termination.

8. Except as modified herein, the Contract remains in full force and effect. All capitalized terms herein shall have the same meaning as set forth in the Contract.


