I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Work Order No. 22-023 to the annual minor construction contract with Randolph Construction Group, Inc. (Contractor) (R2020-0566) for the Four Points – Youth Services 2nd Floor Renovations project in the amount of \$988,362 for a period of 270 calendar days from notice to proceed.

Summary: On June 2, 2020, the Board of County Commissioners (Board) approved the annual minor construction contract with the Contractor (R2020-0566) to provide construction services associated with repairs, improvements and renovations to County properties. Work Order No. 22-023 authorizes renovation services to approximately 13,000 square feet of the 2nd floor Four Points building to include new offices, new work stations, revised electrical and data systems, new flooring, modifications to the existing heating ventilation and air conditioning system, lighting system, and fire alarm system; and new finishes throughout. The renovation services authorized under this work order provide for the reconfiguration of the existing 2nd floor space in order to consolidate the Youth Services Department (YSD) staff into one central location. This project was competitively advertised, and new contractors were invited to bid on the project by submitting prequalification documents prior to the submission of the bid response. The Contractor will have 270 calendar days from notice to proceed to substantially complete the project. Liquidated damages for failure to achieve certification of substantial completion within the contract time or approved time extension thereof are \$550 per day. On August 21, 2019, the Goal Setting Committee applied the following Affirmative Procurement Initiatives (API) for this annual contract: 1) Sheltered market for projects less than \$100,000; or 2) 10% Small Business Enterprises (SBE) Price Preference for single-trade projects \$100,000 or more; or 3) a minimum mandatory 25% SBE subcontracting goal for multi-trade projects. Since this project is a multi-trade project over \$100,000, the applicable API is 25% SBE subcontracting goal. The Contractor is a Small/Minority Business Enterprise (S/MBE) and committed to 62.77% S/MBE participation on this work order. The cumulative SBE participation on the annual minor construction contract is 76.86%. The Contractor is a local business. The funding sources for this project are from the Infrastructure Sales Tax (IST) Fund and the Public Building Improvement Fund. (Capital Improvements Division) District 3 (MWJ)

Background and Justification: This project was openly, competitively advertised and procured. Bids for this project were opened on June 23, 2022. Randolph Construction Group, Inc. submitted the lowest responsive and responsible bid.

WORK ORDER 22-023 TO ANNUAL CONTRACT R2020-0566 FOR MINOR CONSTRUCTION PROJECT NAME: FOUR POINTS – YOUTH SERVICES 2ND FLOOR RENOVATIONS PROJECT NO. 17557

THIS WORK ORDER is made as of ______ by and between Palm Beach County, a political subdivision of the State of Florida, by and through its Board of County Commissioners, hereinafter referred to as "Owner", and Randolph Construction Group, Inc., a Corporation, authorized to do business in the State of Florida, whose Federal ID# is 81-4472641 hereinafter referred to as "Contractor".

WHEREAS, the Owner and Contractor acknowledge and agree that the Contract between Owner and Contractor dated 6/2/20 (R2020-0566) ("Contract") is in full force and effect and that this Work Order incorporates all the terms and conditions of the Contract and the IFB/Q for this project, as may be supplemented and amended by this Work Order;

NOW THEREFORE, in exchange for the mutual covenants and promises set forth herein and the sums of money agreed to be paid by the Owner to the Contractor, the parties agree as follows:

1. Recitals. The foregoing recitals are true and correct and incorporated herein by reference.

2. Total Bid Amount. Pursuant to Section 6.3 of the Instructions to Bidders of the Annual Contract for Minor Construction between Owner and Contractor, the Contractor was the lowest, responsive, responsible Bidder in the amount of \$988,362.00 for the construction costs of renovating second floor while being responsible for, and adhering to the project requirements as set forth on the Bid Form attached hereto and incorporated herein by reference.

3. Schedule of Time for Completion. The time of completion for this Work Order will be as follows: The Contractor shall substantially complete the project within **270** calendar days of construction commencement, as detailed in the Notice to Proceed. Liquidated Damages are \$550/day for failure to achieve certification of substantial completion within the contract time or approved extension thereof.

4. APIs. The APIs applicable to this Contract are attached hereto.

5. EBO Participation to Date. To date Contractor has achieved 72.30% SBE subcontracting participation on this Contract. Contractor will provide 62.77% on this Work Order.

7. <u>Annual Contract Modifications and Additions</u>. The following provisions of the Annual Contract are modified as follows:

Section 5.2 of the "Instructions to Bidders" of the Contract is modified to include the following new section:

5.2.5 Failure to Provide the Required Documents after Notification of Award. If after Notification of award from the County, the successful Bidder does not provide within 14 Days of Notification the signed Work Order, the Public Construction Bond and Guarantee (when required), and the required certificates of insurance, the County may: 1. Call in the bid security when provided; 2. Cancel the notification of recommended award and award the project to the next responsive, responsible low bidder; 3. Terminate this Annual Contract for cause; 4. Suspend or debar the Bidder from bidding on future projects for a period of two (2) years, in accordance with the Palm Beach County Purchasing Ordinance; and/or 5. Pursue any and all remedies available against the Bidder for damages resulting from its failure to enter into a Work Order and provide all required documents within 14 Days after notification.

83.2 Contractor shall obtain from each of its subcontractors an affidavit stating that the subcontractor does not employ, contract with, or subcontract with an Unauthorized Alien,

> as that term is defined in section 448.095(1)(k), Florida Statutes, as may be amended. Contractor shall maintain a copy of any such affidavit from a subcontractor for, at a minimum, the duration of the subcontract and any extension thereof. This provision shall not supersede any provision of this Contract which requires a longer retention period. 83.3 Owner shall terminate this Contract if it has a good faith belief that Contractor has knowingly violated Section 448.09(1), Florida Statutes as may be amended.

83.3.1 If Owner has a good faith belief that Contractor's subcontractor has knowingly violated Section 448.09(1), Florida Statutes, as may be amended, Owner shall notify Contractor to terminate its contract with the subcontractor and Contractor shall immediately terminate its contract with the subcontractor.

83.4 If Owner terminates this Contract pursuant to the above, Contractor shall be barred from being awarded a future contract by Owner for a period of one (1) year from the date on which this Contract was terminated. In the event of such contract termination, Contractor shall also be liable for any additional costs incurred by Owner as a result of the termination.

8. Except as modified herein, the Contract remains in full force and effect. All capitalized terms herein shall have the same meaning as set forth in the Contract.

8. Question: The small Business participation calls for a 25% SBE to be met the project goal. Is this 25% be based on the Base Bid total or all three phase totals combined. Note this can vary depending on how many phases are awarded. Please clarify.

Response: The S/M/WBE participation applies to the entire project, base bid plus alternate 1 and alternate 2.

9. Question: Please confirm that the project will be executed in three distinct Phases. Each Phase will require completion of all the Works by the General Contractor and his subcontractors to accommodate re-population operational assets (materials and Personnel) by the County before another phase is made available to commence work by the General contractor
