


I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: the nomination of Robin Henderson as Chairperson of the Housing Finance Authority of Palm Beach County, Florida (Authority), for the term of September 13, 2022 through September 13, 2023.

Summary: Staff recommends Board of County Commissioners' (BCC) approval of the nomination of Robin Henderson as Chairperson of the Authority. At their regular meeting of June 17, 2022, the Authority Board nominated Mrs. Henderson as its Chairperson to serve a term of one (1) year in accordance with Ordinance No. 2002-022, as amended. This Ordinance requires the nomination of the Chairperson to be submitted to the BCC for approval. Countywide (HJF)

Background and Justification: Section 4 of Ordinance No. 2002-022, as amended, provides in part: "In June of every year, commencing in 2002, the members of the Housing Finance Authority shall nominate a Chairperson, and submit such nomination to the Board of County Commissioners for approval. No member may serve more than two (2) consecutive complete one (1) year terms as Chairperson after the effective date of the Ordinance. The Board of County Commissioners retains the ultimate authority to designate a Chairperson of the Housing Finance Authority."
