The BCC delegated the authority to execute various types of Standard Development Agreements, and related documents including Standard Indemnity Agreements to the Department Director including potable water and wastewater agreements (R93-1619); reclaimed water agreements (R96-0228); and additional conditions for potable water, wastewater, and reclaimed water agreements (R2003-0539).

The Agreement authorizes the Property Owner located on the southeast corner of Polo Road and Lake Worth Road, 269.52 Equivalent Residential Connections (ERC's) for both water and wastewater for five (5) years.
- B) Standard Potable Water and Wastewater Development Agreement with Amelia Estates Phase 2 LLC, SDA #14-0105-000 (District 6), Recorded in OR BK 33514 PG 1921. This Agreement authorizes the Property Owner located north on S.W. 14th Street and south on S.W. 16th Street (S.R. 715), 21.86 ERC's for both water and wastewater for five (5) years.
