I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to receive and file: fourteen (14) fully executed Palm Beach County FY23 Category "CII" Grant Agreements with various grantees totaling \$1,036,617 and managed by the Cultural Council of Palm Beach County, Inc., d.b.a. as Cultural Council for Palm Beach County (Culture) for the promotion/marketing of cultural events (TDC). These grants were approved by the Tourist Development Council on June 9, 2022, for the term October 1,2022 – September 30, 2023.

Summary: In accordance with County PPM CW-O-051, all delegated contracts, agreements and grants must be submitted by the initiating Department as a Receive and File agenda item. On June 7, 1994, the Board of County Commissioners adopted resolution (R94-702) authorizing the Executive Director of the Tourist Development Council to enter into grant agreements with Category "CII" grantees after they have been approved by the Tourist Development Council. (TDC). Cultural organizations with operating budgets ranging from \$100,000 to \$1,174,999 are eligible for Category "C-II" funding. After completing an application for funding the organizations and their programs are reviewed by a grant panel which recommends funding levels. The table of organizations which Culture and the TDC have approved for funding and the amount below itemizes the organizations which Culture and the TDC have approved for funding and the amount based on grant panel scores. The grant agreements will fund events which will promote cultural tourism in Palm Beach County. <u>Countywide (YBH)</u> (Continued on page 3)

Background and Justification: The Agreement (Resolution 94-702) was adopted by the Board to streamline the process of promoting, marketing, and increasing cultural tourism to Palm Beach County. The Board granted the Director of the Tourist Development Council authority to execute Category "CII" Agreements. These fourteen (14) grants agreements have been executed on behalf of the Board by the Executive Director of the Tourist Development Council in accordance with the authority delegated by the Board and are now being submitted to the Board to receive and file.
