**Motion & Title: Staff recommends motion to approve:** The appointment of the following individual to the Citizens' Committee on Airport Noise (CCAN) with a term commencing on October 1, 2022 and expiring on September 30, 2025

**Summary:** Per Resolution No. R-2013-1304, CCAN consists of 11 seats. Four seats are recommended for appointment by the organizations approved by the Palm Beach County Board of County Commissioners (BCC). The Town of Palm Beach Council submitted its recommendation, Lewis Crampton, for representation on CCAN via correspondence to the Palm Beach County Department of Airports. The diversity of the current seven (7) appointees is as follows: Four (4) Caucasian, One (1) African-American, One (1) Hispanic American and One (1) Unknown. The gender ratio (female: male) is 5:2. **Countywide (AH)**

**Background and Justification:** The CCAN was originally created on August 3, 1982 by Resolution No. R-82-199; amended by Resolution R82-804; amended by Resolution R83-857; amended by Resolution R84-977; amended by Resolution R-90-1344, amended by Resolution R-94-1060; amended by Resolution R-2002-0544; amended by Resolution R-2012-0435 and repealed and replaced by Resolution R-2013-1304, adopted October 1, 2013. The CCAN is charged to consider potential noise mitigation methods and suggest programs, concepts or similar matters to the Department of Airports and BCC.

This Committee shall be comprised of 11 members appointed by the Board of County Commissioners as follows: seven members shall be recommended, one each by seven County Commissioners; one member shall be recommended by the Palm Beach County League of Cities; one recommended by the Good Neighbor Council for Aircraft Noise Control; one recommended by the Economic Council of Palm Beach County; and one member shall reside in and represent the area within the Town of Palm Beach and be recommended by the Palm Beach Town Council. The term of membership shall be three years. Terms shall begin October 1st and end on September 30 Beginning on or after March 1, 2013, no member shall be appointed or reappointed to the CCAN for more than three consecutive three year terms.
