I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Release of Utility Easement for that easement recorded in the Official Records of Palm Beach County, ORB 9943, Page 1205.

Summary: Palm Beach County Water Utilities Department (PBCWUD) is seeking the release of the County's interest in the utility easements recorded in the Official Records of Palm Beach County as noted above and located at 5759 Gun Club Road West Palm Beach. The Property Owners are requesting release of the easement that is no longer associated with any public potable water, reclaimed water and wastewater facilities. As a result of site development for the School Board of Palm Beach County, the existing utility easement is no longer required. PBCWUD has determined that the release of this easement will not affect existing or new public potable water, reclaimed water and wastewater facilities and therefore recommends approval of the release. Background and Justification: The utility easement listed above was granted/reserved to the County for public potable water, reclaimed water and wastewater facilities associated with the property identified by PCN 00-42-44-02-01-000-0182 on April 28, 1997.


