#### I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to Approve the Federal Transit Administration (FTA) Master Agreement FTA MA (30) dated November 2, 2022.

**Summary:** The FTA has released its official Master Agreement (FTA MA (30)), which contains the standard terms and conditions that apply to projects financed with funds awarded by the FTA in FY2023. This agreement supersedes the previous FTA MA (29) dated February 7, 2022, approved by the BCC on March 22, 2022 (R2022-0248). **Background and Justification:** The FTA MA (30) is incorporated by reference and made part of each FTA grant award, and amendment thereto, and it encompasses all FTA awards issued until a subsequent Master Agreement is enacted or issued.
