I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to execute: a "Certification By State or Local Official of Public Housing Authority Plans Consistency with the Consolidated Plan or State Consolidated Plan" for the Pahokee Housing Authority (PHA) in connection with its Annual Plan for Fiscal Year 2023.

Summary: The PHA has prepared its Annual Plan for Fiscal Year 2023 for submission to the Department of Housing and Urban Development (HUD). HUD requires the County to confirm that the plans and programs outlined in the Annual Plan are consistent with the goals and objectives set forth in the County's Consolidated Plan. Consistency with the Consolidated Plan is documented through a "Certification by State or Local Official of Public Housing Authority Plans Consistency with the Consolidated Plan or State Consolidated Plan." The Department of Housing and Economic Development (HED) has reviewed the PHA Annual Plan Summary and determined that the goals, objectives, and activities outlined therein are consistent with the Palm Beach County Consolidated Plan for Fiscal Years 2020-2024. Some specific goals outlined in the PHA's Plan which are consistent with the goals set forth in the County's Consolidated Plan are: expand the supply of affordable housing; improve the quality of assisted housing, increase assisted housing choices; provide an improved living environment; promote self-sufficiency and development of individuals and families; and ensure equal opportunity and affirmatively further fair housing. Background and Policy Issues: Palm Beach County's Consolidated Plan contains the County's strategy for addressing housing, economic, and community development needs over a five-year period. HED is responsible for completing the Consolidated Plan in accordance with HUD regulations at 24 CFR Part 91. The current Consolidated Plan, covering the period Fiscal Years 2020-2024, was approved by the Board of County Commissioners on July 14, 2020 (R2020-0926). Approval of this agenda item will allow the PHA to comply with HUD requirements.
