The County has expended or encumbered \$1,834,484 (\$407,663/month) during the previous four and one half (4.5) months of the current ten (10) month term contract. The Fire Rescue Department requests an increase of \$1,000,000 over the previous authorized amount of \$2,235,750, inclusive of the Purchasing Director's ten percent (10%) authority, for the remaining five and one half (5.5) months of the current term contract.
