Motion and Title: Staff recommends motion to approve: Full Release of Utility Easement for that easement recorded in the Official Records of Palm Beach County, ORB 21457 Page 1009.

Summary: Palm Beach County Water Utilities Department (PBCWUD) is seeking the release of the County's interest in the utility easement recorded in the Official Records of Palm Beach County as noted above and located at 101 Sansburys Way, West Palm Beach. The Property Owner requested release of the identified easement that is no longer associated with any public potable water, reclaimed water and wastewater facilities. As a result of site development for Ranger at Sansburys Way Multiple Use Planned Development, the existing identified utility easement is no longer required. PBCWUD has determined that the release of the easement will not affect existing or new public potable water, reclaimed water and wastewater facilities and therefore recommends approval of the release.
