I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to

- A) adopt a Resolution to approve Amendment One (Amendment) to the County Incentive Grant Program (CIGP) Locally Funded Agreement (R2021-0991), dated September 14, 2021 (Agreement) with the State of Florida Department of Transportation (FDOT) for the construction of intersection improvements at SR-809/Military Trail and Forest Hill Boulevard (Project); and
- B) approve the Amendment to the Agreement that increases the total project funding to \$8,301,832 for the Project.

SUMMARY: Approval of this Amendment will increase the total funding for the Project from \$5,539,668 to \$8,301,832. The project cost is shared equally by the County and FDOT through the FDOT CIGP grant. The additional Project funding is \$2,762,164. The County's additional match is \$1,381,082. The additional grant funds are \$1,381,082. Since the Project is being constructed by FDOT, the County will provide its matching funds to FDOT. The Project will add turn lanes, replace the traffic signals, and install lighting at the intersection. The grant amount is being increased to reflect current costs and estimates of the Project. The revised total local match is \$4,150,916 which is 50% of the estimated Project cost. The County will be responsible for all costs above the grant amount and for maintenance of the traffic signals after construction is complete. The Project's construction and construction engineering inspections will be administered by FDOT. This Project is included in the Five-Year Road Program. District 3 (YBH)

Background and Justification: The CIGP is intended to provide grants to local agencies. This Amendment will provide the County additional grant funding for the Project.



THIS Amendment made and entered into this day	, 2023 by and
between the State of Florida Department of Transportation, an agency of the State of	Florida, hereinafter
called the DEPARTMENT, and Palm Beach County, 301 N. Olive Avenue, West F	Palm Beach, Florida
33401, hereinafter called the COUNTY.	

WITNESSETH

WHEREAS, on September 14, 2021, the parties entered into a County Incentive Grant Program Locally Funded Agreement, hereinafter referred to as the Agreement, wherein the COUNTY agreed to provide the DEPARTMENT financial assistance in connection with Financial Management (FM) No. 437878-1-52-01; 437878-1-62-01, and 437878-1-62-02 for the construction of intersection improvements of SR-809/Military Trail at Forest Hill Boulevard in Palm Beach County, Florida, hereinafter referred to as the Project; and

WHEREAS, the COUNTY has provided the DEPARTMENT with funding for the Project. The payment was received on October 8, 2021 in the amount of TWO MILLION SEVEN HUNDRED SIXTY-NINE THOUSAND EIGHT HUNDRED THIRTY-FOUR DOLLARS AND NO CENTS (\$2,769,834.00) and has been applied to Project FM Numbers 437878-1-52-01; 437878-1-62-01, and 437878-1-62-02; and

WHEREAS, the purpose of this Amendment is to increase the total funding for the Project and thereby the COUNTY's financial contribution; and

WHEREAS, the parties hereto mutually agree that this Amendment is in their best interest.

NOW, THEREFORE, in consideration of the mutual covenants, promises, and representations herein, the parties agree to amend that certain Agreement as follows:

- 1. The recitals set forth above are true and correct and are deemed incorporated herein.
- 2. Paragraph 4 (B) of the Agreement is hereby deleted and replaced as follows:

The total cost for the Project is estimated to be EIGHT MILLION THREE HUNDRED ONE THOUSAND EIGHT HUNDRED THIRTY-TWO DOLLARS AND NO CENTS (\$8,301,832.00). The COUNTY'S cost for the Project is estimated at FOUR MILLION ONE HUNDRED FIFTY THOUSAND NINE HUNDRED SIXTEEN DOLLARS AND NO CENTS (\$4,150,916.00) which sum the COUNTY shall pay the DEPARTMENT.

The parties agree that each Project phase (construction, CEI services, and post design) has its own funding allocation. In the event there are unused, excess funds remaining in any Project phase, that remaining amount can be used by the DEPARTMENT for any other Project phase without the parties entering into an amendment.

3. Paragraph 4 (G) of the Agreement is hereby deleted and replaced as follows:

The COUNTY agrees that it will, within fourteen (14) days of the execution of this Amendment, furnish the DEPARTMENT with a check in the amount of ONE MILLION THREE HUNDRED EIGHTY-ONE THOUSAND EIGHTY-TWO DOLLARS AND CENTS (\$1,381,082.00) for the remaining funding required for the construction of intersection improvements of SR809/Military Trail at Forest Hill Boulevard.

In the event payment is not received by the DEPARTMENT within fourteen (14) days of execution of this Amendment, the DEPARTMENT reserves the right to remove the construction of intersection improvements of SR-809/Military Trail at Forest Hill Boulevard from the Department's work.

Remittance shall be made payable to the Department of Transportation. Payment shall be clearly marked to indicate that it is to be applied to FM Number 437878-1-52-01; 437878-1-62-01, and 437878-1-62-02. The DEPARTMENT shall utilize this amount towards the costs of Project No. 437878-1-52-01; 437878-1-62-01, and 437878-1-62-02.
