FIRST AMENDMENT TO THE TRI-PARTY AGREEMENT BETWEEN

PALM BEACH COUNTY, THE CITY OF BOCA RATON AND ESPN PRODUCTIONS, INC. FOR ESPN-BOCA RATON BOWL GAME AT FLORIDA ATLANTIC UNIVERSITY STADIUM

WITNESSETH

WHEREAS, on December 7, 2021, the PARTIES entered into the Agreement for ESPN to produce an annual NCAA Division I Football Game; and

WHEREAS, while the AGREEMENT includes an expiration date of July 31, 2023, it also provides that it may be renewed for a period of three additional years ending on February 28, 2026; and

WHEREAS, this is the only allowable renewal of the AGREEMENT provided therein; and

WHEREAS, the renewal must be exercised by the PARTIES on or before July 1, 2023; and

WHEREAS, by this First Amendment, the CITY, ESPN, and the COUNTY mutually agree to amend the AGREEMENT to renew and extend its term through February 28, 2026, as provided herein.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the **PARTIES** agree as follows:


- 1. The above recitations are true and correct and are incorporated herein.
- 2. The **AGREEMENT** is hereby amended to renew the **AGREEMENT** for a three (3) year term, commencing on August 1, 2023 and expiring on February 28, 2026.
- 3. It is the intent of the **PARTIES** hereto that this First Amendment shall not become binding until the date executed by all of the **PARTIES**.
- 4. Except as provided herein, all other terms, conditions, and provisions of the **AGREEMENT** shall remain in full force and effect.

A RESOLUTION OF THE CITY OF BOCA RATON AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE THE FIRST AMENDMENT TO THE TRI-PARTY AGREEMENT BETWEEN PALM BEACH COUNTY, THE CITY OF BOCA RATON, AND ESPN PRODUCTIONS, INC. FOR THE ESPN-BOCA RATON BOWL GAME AT FLORIDA ATLANTIC UNIVERSITY STADIUM; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEALER; PROVIDING AN EFFECTIVE DATE

WHEREAS, the City of Boca Raton, pursuant to Resolution No. 164-2021, has entered into a Tri-Party Agreement Between Palm Beach County, the City of Boca Raton and ESPN Productions, Inc. for ESPN-Boca Raton Bowl Game at Florida Atlantic University Stadium ("Agreement") with Palm Beach County, ESPN Productions, Inc. and the City of Boca Raton for the ESPN-Boca Raton Bowl Game at Florida Atlantic University Stadium in Boca Raton; and

WHEREAS, the parties desire to amend the Agreement to provide for the renewal of the Agreement through February 28, 2026; and

WHEREAS, the Tri-Party Agreement between the County, the City and ESPN for the Boca Raton Bowl at Florida Atlantic University ("Tri-Party Agreement") between the City, the County and ESPN has been prepared and a copy is attached hereto; now therefore

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BOCA RATON:

Section 1. That the Mayor and City Clerk be authorized to execute the First Amendment to the Tri-Party Agreement between Palm Beach County, the City of Boca Raton and ESPN Productions, Inc. for ESPN-Boca Raton Bowl at Florida Atlantic University Stadium, a copy of which is attached hereto, together with such nonmaterial changes as may be acceptable to the City Manager.

<u>Section 2</u>. If any section, subsection, clause, or provision of this resolution is held invalid, the remainder shall not be affected by such invalidity.

<u>Section 3</u>. All resolutions or parts of resolutions in conflict herewith shall be and hereby are repealed.

Section 4. This resolution shall take effect 10 days after adoption.
