I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: An Interlocal Agreement (ILA) with the Village of Royal Palm Beach providing for the annexation of an enclave, known as the Sunset Isles Condominiums generally located on the South side of Okeechobee Blvd., west of N. State Road 7.

Summary: The Village of Royal Palm Beach (Village) adopted an interlocal agreement on April 20, 2023, for the annexation of an enclave totaling 18.40 acres, identified in Exhibit A of the Interlocal Agreement. The proposed annexation was processed through the County's reviewing departments, including Fire Rescue; Engineering; Planning, Zoning & Building; Environmental Resources Management; Parks and Recreation; Water Utilities; County Attorney; Property and Real Estate Management; Sheriff's Office; and the Office of Financial Management and Budget. The Village provided written notice to all owners of real property located within the enclave. The proposed annexation meets the requirements of Chapter 171, F.S., and is consistent with the Intergovernmental Coordination Element of the County's Comprehensive Plan. District 6 (DL)

Background and Justification: Chapter 171, Florida Statutes (F.S.), allows for annexation of enclaves less than 110 acres through an Interlocal Agreement between the annexing municipality and the County. This annexation meets the requirements of Chapter 171.046, F.S., for annexation by Interlocal Agreement, as it is less than 110 acres in size, and consists of developed properties. The annexation meets the definition of enclave as it is an unincorporated improved or developed area that is enclosed within and bounded by a single municipality. By Resolution No. 23-05 adopted on April 20, 2023, the Village has petitioned the County to enter into an Interlocal Agreement for the annexation of the enclave. The proposed annexation is consistent with the Intergovernmental Coordination Element, Objective 1.4, of the County's Comprehensive Plan, which encourages the elimination of enclaves. The proposed annexation is located within the Village's Future Annexation Area.

RESOLUTION NO. 23-05

A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF ROYAL PALM BEACH, FLORIDA AUTHORIZING THE MAYOR TO EXECUTE AN INTERLOCAL AGREEMENT WITH PALM BEACH COUNTY PURSUANT TO SECTIONS 163.01 AND 171.046, FLORIDA STATUTES, FOR THE ANNEXATION OF ONE ENCLAVE CONSISTING OF TWO HUNDRED THIRTY TWO PARCELS TOTALING LESS THAN ONE HUNDRED AND TEN ACRES, AS MORE FULLY DESCRIBED IN THE ATTACHED INTERLOCAL AGREEMENT; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, said enclave known as Sunset Isles is comprised of 232 individual parcels of land amounting to less than one hundred ten acres in total size; and

WHEREAS, the Village Council of the Village of Royal Palm Beach desires to annex said enclave into the Village; and

WHEREAS, Section 171.046, Florida Statutes provides that such enclave may be annexed into the Village pursuant to an Interlocal Agreement between the Village and Palm Beach County; and

WHEREAS, the Village Council of the Village of Royal Palm Beach, Florida believes that the annexation of said enclave will serve to promote the public health, safety and welfare, and hereby authorizes the Mayor of the Village of Royal Palm Beach to execute the attached Interlocal Agreement to effectuate said annexation.





EXHIBIT "A"
INTERLOCAL AGREEMENT

INTERLOCAL AGREEMENT FOR ENCLAVE ANNEXATION

THIS INTERLOCAL AGREEMENT FOR ENCLAVE ANNEXATION is made on this _____ day of _____, 2023 between the VILLAGE OF ROYAL PALM BEACH, a municipal corporation located in Palm Beach County, Florida, hereinafter referred to as "VILLAGE," and PALM BEACH COUNTY, a political subdivision of the State of Florida, hereinafter referred to as "COUNTY", each entity constituting a "public agency" as defined in Part 1, Chapter 163, Florida Statutes (2022).

WHEREAS, Section 163.01, Florida Statutes (2022), known as the "Florida Interlocal Cooperation Act of 1969," as amended, authorizes local governments to make the most efficient use of their powers by enabling them to cooperate with other localities on a basis of mutual advantage, and to thereby provide services and facilities which will harmonize geographic, economic, population, and other factors influencing the needs and development of local communities; and

WHEREAS, the "Florida Interlocal Cooperation Act of 1969" permits public agencies as defined herein to enter into interlocal agreements with each other to jointly exercise any power, privilege, or authority which such agencies share in common and which each might exercise separately; and

WHEREAS, Section 171.046, Florida Statutes (2022), provides for annexation of certain enclaves by entering into an interlocal agreement between the municipality and the county having jurisdiction over such enclave; and

WHEREAS, Section 171.046, Florida Statutes (2022), limits annexation by interlocal agreement to enclaves of 110 acres or less in size; and

WHEREAS, Section 171.031 (13) (a) and (b), Florida Statutes (2022), defines enclaves as developed or improved property bounded on all sides by a single municipality, or bounded by a single municipality and by a natural or manmade obstacle that allows passage of vehicular traffic to that incorporated area only through the municipality; and

WHEREAS, the County and the Village have determined that it is appropriate and will promote efficient provision of governmental services for the Village to annex certain enclaves; and

WHEREAS, it has been determined by the Village and by the County that the parcels to be annexed via this interlocal Agreement meet the requirements set out in Section 171.031 (a) and (b) and 171.046, Florida Statutes (2022), as such enclave is developed or is improved, is 110 acres or less in size, and is completely surrounded by the Village or is surrounded by the Village and a natural or manmade obstacle that allows passage of vehicular traffic to the enclaves only through the Village; and

WHEREAS, the Village's Comprehensive Plan in Objective LU-1.6 states that by 2013, the Village shall coordinate with the Village of Wellington, the City of West Palm Beach, the Town of Loxahatchee Groves, Palm Beach County, and other impacted local governments to develop and refine a joint annexation plan and strategy that provides mutual benefits; and addresses regional planning and development goals; and

WHEREAS, the Village's Comprehensive Plan Policy LU-1.6.3 provides that the Village shall designate future annexation areas on the Future Land Use Map and coordinate with the affected land owners, governments and agencies for the future annexation and land uses of these areas; and

WHEREAS, the enclave to be annexed is identified as a Village of Royal Palm Beach future annexation area on the Palm Beach County Municipal Future Annexation Areas map dated September 1, 2020; and

WHEREAS, the County and the Village agree that the parcels to be annexed via this Interlocal Agreement are subject to the Land Use Atlas of the Palm Beach County Comprehensive Plan and County zoning and subdivision regulations until the Village adopts a comprehensive plan amendment to include the parcels to be annexed into the comprehensive plan.

NOW, THEREFORE, in consideration of the mutual representations, terms, and covenants hereinafter set forth, the parties hereby agree as follows:

Section 1. Purpose

The purpose of the Agreement is to allow annexation by the Village of Royal Palm Beach of certain unincorporated enclave which is identified in Exhibits "A" and "B" attached hereto and made a part hereof:

Section 2. Definitions

The following definitions shall apply to this Agreement:

1. The term "enclave" shall be defined as set forth in Section 171.031(13) (a) and (b), Florida Statutes (2022).
2. "Act" means Part 1 of Chapter 163, Florida Statutes (2022).
3. "Agreement" means this Interlocal Agreement, including any amendments or supplements hereto, executed and delivered in accordance with the terms hereof.

Section 3. Annexation

The unincorporated enclave identified in Exhibits "A" and "B", which is attached hereto and made a part hereof, is hereby annexed into and is included in the corporate boundaries of the Village of Royal Palm Beach.

Section 4. Effective Date

This agreement shall take effect upon execution by both parties.

Section 5. Filing

Upon execution by both parties, a certified copy of this agreement shall be filed with the Clerk of Circuit Court in and for Palm Beach County.

Section 6. Notification

The Village hereby acknowledges that it has provided written notice to all owners of real property located in the enclave identified in Exhibits "A" and "B" whose names and addresses are known by reference to the latest published ad valorem tax records of the Palm Beach County

Property Appraiser. The written notice described the purpose of the Interlocal Agreement and stated the date, time, and place of the meeting of the Village Council of the Village of Royal Palm Beach where this Interlocal Agreement is to be considered for adoption. The written notice also indicated the name and telephone number of the Palm Beach County staff person to contact regarding the date, time and place when the Board of County Commissioners is to consider the adoption of this Interlocal Agreement.

Section 7. Captions

The captions and section designations herein set forth are for convenience only and shall have no substantive meaning.

Section 8. Severability

In the event any section, paragraph, sentence, clause, or provision hereof is held by a court of competent jurisdiction to be invalid, such shall not affect the remaining portions of this Agreement, and the same shall remain in full force and effect.

Section 9. Entire Agreement & Counterparts

This Agreement represents the entire understanding between the parties, concerning the subject, and supersedes all other negotiations, representation, or agreements, either written or oral, relating this Agreement. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.


