Our building laboratory has been operating without a functional generator for over twelve months. The proposed redundant auxiliary power source would allow us to serve the public without interruption in case of an emergency that could contaminate potable water wells. The Environmental Public Health Division would be collecting water samples from potable water wells while conducting environmental health assessments after landfall of a major storm. The samples would be analyzed at our local laboratory providing a quick turnaround of results and hence help prevent potential waterborne illnesses.

WHEREAS, the Board of County Commissioners of Palm Beach County, Florida adopted Resolution No. R-89-576 on April 4, 1989, establishing the Palm Beach County Pollution Recovery Trust Fund (PRTF) to receive monies collected in instances of environmental violations; and

WHEREAS, it is appropriate to utilize monies from the Palm Beach County Pollution Recovery Trust Fund for pollution control activities in Palm Beach County; and

WHEREAS, the Palm Beach County PRTF has sufficient funds derived from penalties collected as a result of environmental violations prosecuted through the enforcement efforts of the Department of Health Palm Beach County (DOH PBC) and other sources; and

WHEREAS, one of the most effective means to assess pollution control activities is to conduct monitoring; and

WHEREAS, the Department of Health Palm Beach County monitors water quality in drinking water and coastal water.

WHEREAS, the Department of Health will be able to serve the community better during disaster response efforts.

WHEREAS, the Director of the Department of Health Palm Beach County recommends that \$83,183 from the Pollution Recovery Trust Fund be used by the Health Department to install a generator in the microbiology laboratory.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, THAT:

Section 1: The foregoing recitals are hereby adopted and ratified.

Section 2: The Board hereby authorizes the Clerk and Comptroller to transfer \$83,183 from the Palm Beach County Pollution Recovery Trust Fund to the Department of Health Palm Beach County to install a generator in the microbiology laboratory.

Request Submitted By: Environmental Resources Management

Motion and Title:

STAFF RECOMMENDS MOTION TO APPROVE resolution establishing a Falm Beach County Pollution Recovery Trust Fund; providing that monies deposited be utilized to restore and/or enhance Palm Beach County's environmental resources. This recommendation was conceptually approved at the March 21, 1989 BCC workshop as Issue #2.

Background and Justification:

The Department's current contract with the State for pollutant storage tank compliance activities provides for annual inspections of most of the fuel storage facilities in the County. In the first year of the program, the primary emphasis has been on identifying violations and assisting the owner or operator of the facility in correcting the noted deficiencies. Upon completion of this initial round of inspections, greater emphasis will be placed on enforcement.

Facilities with repeat violations and facilities that fail to properly correct violations will be subject to penalties under the current State policy. Under terms of the Department's contract with the State, the County will be required to implement State policy with regard to enforcement actions and collection of penalties.

Under guidelines established by the State, monies collected within the County can remain in the County and be utilized for environmental restoration and enhancement projects, provided that a trust fund is created and properly managed. If the fund is not astablished, penalty settlements collected in the storage tank program or penalties collected in joint County/Florida Department of Environmental Regulation enforcement actions must be directed to the State's Pollution Recovery Trust Fund. Facility owners are never pleased with a requirement to pay a penalty. However, penalties are often more palatable when used for environmental resource restoration or enhancement projects, rather than for staff salaries or operating costs.

Requests and recommendations for use of the trust fund would be prepared by the Department and presented to the Board of County Commissioners for review and approval. The Palm Beach County Health Unit has expressed support for creation of the fund and may wish to utilize it in the future.



This recommendation was conceptually approved as Issue No. 3 at the March 21, 1989 BCC workshop.
- 4. Staff recommends motion to approve: An additional position in the Department of Environmental Resources Management. The position would provide for management of County-owned pollutant storage tanks, management of contamination cleanup activities on County-owned property and coordination of environmental audits for proposed County acquisitions. Funding for the remainder of FY 1988-89 will be with currently budgeted funds. This recommendation was conceptually approved at the BCC workshop on March 21, 1989, issues #5, #11 and #14.
