I. EXECUTIVE BRIEF

Motion and Title:

Staff recommends motion to receive and file proof of publications: “Unclaimed Monies” advertised by the Clerk of the Circuit Court & Comptroller of Palm Beach County.

Summary:

Pursuant to Section 116.21, Florida Statutes, the Clerk advertised certain unclaimed monies held which are subject to forfeiture to Palm Beach County. Florida Statutes 116.21 requires that the proof of publication “shall be filed and recorded in the minutes of the County Commission of such county.”

Background and Justification:

This advertised list of monies represents all unclaimed monies deposited or collected by them in their official capacity, which came into their hands prior to January 1 of the preceding year.

Monies received are deposited into the Fine and Forfeiture Fund.


Payment of advertising costs is made by the Clerk & Comptroller.
