# Motion and Title: Staff recommends motion to:

- A) accept Urban Area Security Initiative (UASI) GY 2022 Award Letter; and
- **B) receive and file** Memorandum of Agreement (MOA) UASI FY 2022 agreement number R0588 with the City of Miami to receive \$610,726 in reimbursable grant funding for the period July 26, 2023 through June 30, 2024; and
- **C)** approve Budget Amendment of \$566,697 in the (UASI) Grant Fund to adjust the budget to the actual grant award.

**Summary:** This MOA (CFDA # 97.067) provides a means of funding various domestic security activities within the County using Federal UASI funds through the City of Miami as the UASI's fiscal agent. UASI awarded \$610,726 to the County's Public Safety Department Division of Emergency Management for planning, training and exercise, logistics/deployable equipment, equipment for All Hazards Incident Management Team, and regional Citizen Corps/CERT planning, training, exercise and equipment. R2013-0622 gave authority to the County Administrator or designee, to execute these agreements on behalf of the Board of County Commissioners; that do not substantially change the scope of work, terms or conditions of the MOA. **No County matching funds are required.** <u>Countywide</u> (DB)

**Background and Justification:** In 2006, the State of Florida and the Federal Department of Homeland Security created the UASI using the cities of Fort Lauderdale, Miramar, Miami Gardens, Hollywood, and Coral Springs as the core cities. At the first organizational meeting of the UASI, the core cities invited the counties of Broward and Palm Beach to participate as equal partners. Subsequently, the City of Coral Springs and the Sheriff's Office of Broward and Palm Beach Counties were also invited to participate as equal partners. In May of 2011, the Miami UASI and the Fort Lauderdale UASI were combined by the Department of Homeland Security into the Fort Lauderdale/Miami UASI. The City of Miami has accepted the duties and responsibilities of representing the UASI to the State and Federal governments as the UASI's fiscal agent and point of contact.
