


<p>The Palm Beach County Sheriff's Office (PBSO), the lead law enforcement applicant, and Catholic Charities Diocese of Palm Beach (CCDPB), the lead victim service provider applicant, are each requesting \$750,000 under Purpose Area 2: Expansion of Local Human Trafficking or Tribal ECM Human Trafficking Task Forces. The combined \$1,500,000 will support continued and expanded activities through the Palm Beach County Human Trafficking Task Force (Task Force) during the next 36- month project period. The Task Force was formed in 2017, as part of a 2016 ECM grant award from BJA and OVC to combat all forms of human trafficking in PBC. Through a 2019 ECM award, the Task Force was able to strengthen and evolve.</p> <p>The Task Force is comprised of a diverse membership joined through a formal Memorandum of Understanding. This collaborative approach must include victim and social service providers, law enforcement and prosecution personnel (local, state, and federal), survivors, and a range of other governmental and non-governmental partners that work together to provide a diverse set of appropriate services for trafficking victims.

None of the following activities will be conducted whether under the Office of Justice Programs federal action or a related third party action:

- (1) New construction
- (2) Any renovation or remodeling of a property located in an environmentally or historically sensitive area, including property (a) listed on or eligible for listing on the National Register of Historic Places, or (b) located within a 100-year flood plain, a wetland, or habitat for an endangered species
- (3) A renovation that will change the basic prior use of a facility or significantly change its size
- (4) Research and technology whose anticipated and future application could be expected to have an effect on the environment
- (5) Implementation of a program involving the use of chemicals (including the identification, seizure, or closure of clandestine methamphetamine laboratories)

These documents should include, but are not limited to, those used for program eligibility, intake, working with participants, and program protocols. The recipient further agrees to work with OVC-sponsored technical assistance provider(s) to develop or modify its policies, procedures, and rules where OVC determines that changes are needed to ensure they reflect best practices for serving survivors of human trafficking.
