Summary: In accordance with County PPM CW-O-051, all delegated contracts/agreements/grants/ procurement items must be submitted by the initiating Department as a receive and file agenda item and are attached unless the documents have been recorded in the Public Records of Palm Beach County. The documents have been fully executed on behalf of the Board of County Commissioners (BCC) by the Director of the Palm Beach County Water Utilities Department (PBCWUD) in accordance with Resolutions R93-1619, R96-0228, and R2003-0539 and are now being submitted to the BCC to receive and file. Background and Justification: PBCWUD's Uniform Policies and Procedures require Standard Development Agreements to obtain concurrency for water and/or wastewater service. The terms and conditions for Standard Development Agreements are outlined in the PBCWUD Uniform Policies and Procedures Manual. The BCC delegated the authority to execute various types of Standard Development Agreements, and related documents including Standard Indemnity Agreements to the Department Director including potable water and wastewater agreements (R93-1619); reclaimed water agreements (R96-0228); and additional conditions for potable water, wastewater, and reclaimed water agreements (R2003-0539).

- A) Standard Potable Water and Wastewater Development Agreement with W & W XXIV, LLC, SDA #05-11134-000 (District 6), Recorded in OR BK 34435 PG 698. This Agreement authorizes the Property Owner located along the south side of Lantana Road, north of Hypoluxo Road and east of Lyons Road, 42.10 Equivalent Residential Connections (ERC's) for both water and wastewater for five (5) years.
- B) Standard Reclaimed Water Development Agreement with Pebb Atlantic II, LLC and Socro LLC, SDA #09-90018-000 (District 5), Recorded in OR BK 34435 PG 680. This Agreement authorizes the Property Owner located along the south side of Atlantic Avenue between Lyons Road and Persimmons Avenue to reserve reclaimed water.
- C) Standard Reclaimed Water Service Agreement Direct System with Pebb Atlantic II, LLC and Socro LLC, SRWSA #09-90018-000 (District 5), Recorded in OR BK 34435 PG 689. This Agreement authorizes the Property Owner located along the south side of Atlantic Avenue between Lyons Road and Persimmons Avenue to direct access of reclaimed water for irrigation purposes.
- D) Amendment to Standard (Potable Water, Wastewater, and/or Reclaimed Water) Development Agreement with Principal Development Group, LLC, SDA #03-01052-000 (District 5), Recorded in OR BK 34435 PG 677. This Agreement authorizes the Property Owner located on the NW corner of Atlantic Avenue and Hagen Ranch Road, 12.76 ERC's for both water and wastewater for five (5) years.
