I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Consultant Services Authorization (CSA) No. 1 to the Consulting/Professional Services Wastewater Engineering Services (Contract) with Hazen and Sawyer, P.C. (Consultant) for Owner's Representative Services During Construction for Green Cay Phase 2 Progressive Design-Build (Project) for a not to exceed amount of \$1,507,796.88.

Summary: On December 5, 2023, the Board of County Commissioners approved the Palm Beach County Water Utilities Department (PBCWUD) Contract (R2023-1785) with Consultant. The Project includes the construction of a new Water Purification Facility (WPF) located at the Southern Region Water Reclamation Facility (SRWRF) capable of treating two (2) million gallons per day (MGD) of purified water, a new state-of-the-art education/learning facility colocated with the WPF, a new sixty-three (63) acre public park with purified waterways located at the corner of Jog and Flavor Pict Roads, two (2) new surficial aquifer production water wells and associated water transmission lines. To support execution of the Project, CSA No. 1 provides for owner's representative services during construction including, but not limited to, construction management services, field observations, contract administration.

This Contract was procured under the requirements of the Equal Business Opportunity Ordinance. On April 5, 2023, the Goal Setting Committee applied an Affirmative Procurement Initiative (API) of a minimum mandatory 20% Small Business Enterprise (SBE) subcontracting goal and an evaluation preference for up to 15 points based upon the relative level of dollar participation by African American owned firms. The Contract provides for 32% SBE participation, which includes 32% M/WBE participation, 20% MBE (B), 7% MBE (A), and 5% WBE. CSA No. 1 includes 0% SBE participation, which includes 0% M/WBE, 0% MBE (B), and 0% WBE. While Consultant is headquartered in New York, New York, they maintain an office in Palm Beach County from which the majority of the work under this CSA will be performed. The Project is included in the PBCWUD FY24 budget. (PBCWUD Project No. 20-036) District 5 (MWJ)

Background and Justification: Consultant will assist PBCWUD with monitoring the construction phase of the Project. These construction management services will maximize the value of the project during construction through services to enforce contract requirements, coordinate construction activities with stakeholders, and review the contractor's documentation.

SCOPE OF SERVICES

PBCWUD Project No.: 20-036

Project Title: Green Cay Phase 2 Progressive Design-Build Owner's Representative Services

The COUNTY entered into a Progressive Design Build contract with CDM Constructors Inc. (DESIGN-BUILDER) to design and construct new facilities adjacent to the existing Green Cay Wetlands and Nature Center. This project entitled Green Cay Phase 2 (Project) will consist of a park, a water purification facility, and a learning center. The design of the Project is near completion and construction is scheduled to commence in early January 2024. Final completion of the Project is anticipated in August 2026.

The COUNTY has requested Hazen and Sawyer, P.C. (CONSULTANT) serve as the COUNTY's Owner's Representative during the construction phase of the Project. The CONSULTANT as the COUNTY's Owner's Representative will serve as the COUNTY's liaison on a daily basis throughout the entire duration of the construction phase of the Project. It is anticipated that the contract time will be 956 continuous calendar days from Construction Notice to Proceed to Construction Final Completion and 60 continuous calendar days from Construction Final Completion to Project Closeout.

Specific duties to be provided by the CONSULTANT as the Owner's Representative will include but not be limited to daily observation of construction activities, progress reports to COUNTY on a routine basis, participation in progress meetings, monitoring of project progress, approval of contractor applications for payment, monitoring of shop drawings and requests for information submittals, assistance in operator training coordination, observation of startup and testing of equipment and systems, and additional services as identified in the following tasks.

Task 1 – Services During Construction (SDC)

The specific SDC phase services to be provided by the CONSULTANT include the tasks listed as follows. The CONSULTANT will complete the tasks within the timeframe associated with the Contract Documents for this project. Assistance is specific to the following:

Item 1.1 – Pre-construction Conference

The CONSULTANT will attend a preconstruction conference with representatives of the DESIGN-BUILDER and major subcontractors. The CONSULTANT will review meeting minutes issued by the DESIGN-BUILDER and provide comments as necessary.

Item 1.2 - Review of Baseline Project Schedule

The CONSULTANT will review the DESIGN-BUILDER's preliminary (baseline) project schedule and provide written comments to the DESIGN-BUILDER as needed. The CONSULTANT will directly coordinate with the COUNTY staff to account for any additional comments.

Item 1.3 - Submittals Monitoring and Documentation

The CONSULTANT will monitor the status of the following submittals:

- · Shop Drawings (major process mechanical equipment)
- · Requests for substitution
- · Requests for additional information (RFIs) and Clarification

The DESIGN-BUILDER will be responsible for the detailed review and response to the Project submittals. The CONSULTANT will monitor the reviews and responses provided by the DESIGN-BUILDER and advise the COUNTY of any coordination items or concerns associated with DESIGN-BUILDER proposed substitutions.

Item 1.4 – Progress Meetings

The CONSULTANT will attend construction progress meetings to be held at the Project site. The CONSULTANT will review meeting minutes issued by the DESIGN-BUILDER and provide comments as necessary.

Item 1.5 - Owner Purchased Equipment and Sales Tax Recovery Documentation Assistance

The CONSULTANT will assist the COUNTY with the processing of Owner Purchased Equipment and Sales Tax Recovery documentation. The Owner Purchased Equipment items anticipated include:

- Sump pumps
- Process Mechanical Valves
- Stainless Steel Process Pipe
- Ductile Iron Pipe and Accessories
- RO Feed Water Pumps
- MF-UF and RO Equipment
- UV AOP Equipment
- Chemical Pump Skids
- Chemical Tanks
- Static Mixers

Item 1.6 - Applications for Pay Estimate and Profit Sharing Status Reports

The CONSULTANT will review the DESIGN-BUILDER Schedule of Values and monthly payment applications in conformance with the Contract Documents submitted in a format acceptable to the COUNTY. The CONSULTANT will also review the DESIGN-BUILDER profit sharing status reports. The CONSULTANT will verify the quantities as represented on the pay request and profit sharing status reports and make a recommendation to the COUNTY to proceed with the payment as requested, or as modified based on the CONSULTANT's review.

The CONSULTANT will monitor the status of construction drawing red-lines as part of the application for payment review.

Item 1.7 – Construction Schedule Review

The CONSULTANT will monitor the progress of construction activities and review the monthly schedule updates. The CONSULTANT will provide written review comments to the DESIGN-BUILDER and coordinate with the COUNTY to incorporate any additional comments.

Item 1.8 - Construction Changes

The CONSULTANT will prepare, process, and negotiate change orders during the construction period. The CONSULTANT will prepare and maintain a diary or log book recording changes in conditions and change orders. The CONSULTANT will also monitor, document, and advise the COUNTY of any Project changes resulting in impacts to the construction cost to negotiate profit sharing or use of the Progressive Design Build contract allowance and contingencies.

Item 1.9 - Commissioning Oversight

The CONSULTANT will provide commissioning oversight, including review of commissioning plans, attend coordination meetings, witness field tests, and participate in other startup activities needed to demonstrate the successful operation of the facility. The CONSULTANT will document the results of the start-up activities and notify the COUNTY of any significant milestones and/or critical activities.

It is assumed that the DESIGN-BUILDER will be responsible for preparing start-up plans, perform all of the preliminary testing required to troubleshoot any and all systems prior to the field start-up of equipment, and the installation of the equipment has been reviewed by the DESIGN-BUILDER and appropriate equipment manufacturers for conformance with the Contract Documents.

Item 1.10 – Operator Training Coordination

The CONSULTANT will coordinate between the DESIGN-BUILDER commissioning manager and the COUNTY for operator training. On-site training will be conducted by the DESIGN-BUILDER and equipment and software manufacturers with COUNTY operations and maintenance staff to review the function of new equipment and software furnished under the Project.

Item 1.11 - Substantial and Final Completion and Certificate of Construction Completion

The CONSULTANT will attend the substantial and final completion inspections with the COUNTY and the DESIGN-BUILDER to determine if the project has been completed in accordance with the Contract Documents and if the DESIGN-BUILDER has fulfilled his obligations thereunder. The DESIGN-BUILDER will notify the COUNTY and the CONSULTANT that the Project has reached substantial and final completion before inspections are performed. For the purpose of this subtask, Substantial Completion shall be deemed to be the stage in construction of the project where the project can be utilized for the purposes for which it was intended, and where minor items need not be fully completed, but all items that affect the operational integrity and function of the project are capable of continuous use. A punch-list will be prepared by the DESIGN-BUILDER for each inspection (substantial & final) for the Project. The CONSULTANT will coordinate with the COUNTY to ensure all items identified by the COUNTY are included in the punch-list(s) and will monitor resolution of punch-list items and verify that all punch-list items have been completed.

Item 1.12 - Project Closeout and Final Submittal Review

The CONSULTANT will attend the final project reconciliation meetings with the DESIGN-BUILDER and other COUNTY staff. The CONSULTANT will provide a recommendation to the COUNTY to proceed with final payment to the DESIGN-BUILDER once all closeout items have been received for the Project.

Item 1.13 - General Administration of Contract

The CONSULTANT will provide the COUNTY with a bi-weekly Project status report. The Project status report will summarize the following:

- Schedule Update Status major milestones accomplished, major activities in progress and major activities to be completed in the next 4 weeks, slipping activities, and potential delays.
- Application for Payment total construction cost, cost spent to date compared to construction average construction completion, average monthly burn-rate, profit sharing status, change orders, and use of the Progressive Design Build contract allowance and contingencies.
- Copies of daily reports and pictures representative of work performed and reports of nonconformance issues during that period.

Item 1.14 - Construction Observation Services

The CONSULTANT will perform construction observation of the Project during the construction of the work in a total period of not-to-exceed 956 calendar days for the Contract Documents. Activities performed under this task consist of observation of the quality of the construction work, and to determine, in general, if the construction can be certified to the COUNTY by the DESIGN-BUILDER.

Daily field reports will be prepared and maintained by the CONSULTANT documenting activities performed under this task.

The CONSULTANT will:

- Serve as the COUNTY's on-site representative and liaison between the COUNTY and the DESIGN-BUILDER, working primarily through the DESIGN-BUILDER's construction manager, superintendent, and inspector.
- Conduct observations of the work and its progress as it relates to the overall project schedule and general compliance with the Contract Documents

Task 2 - Project Management

Throughout the duration of the project, the CONSULTANT will provide project controls and management services associated with the CONSULTANT's scope of work. The CONSULTANT will provide monthly reports to the COUNTY's project manager summarizing activities accomplished on a monthly basis and anticipated work for upcoming month.

ASSUMPTIONS

Work described herein is based upon the assumptions listed below. If conditions differ from those assumed in a manner that will affect the scope of this consultant services authorization, the CONSULTANT will advise the COUNTY in writing of the magnitude of the required adjustments. Changes in completion schedule or compensation to the CONSULTANT will be negotiated with the COUNTY. Services to be provided by the COUNTY and other related key assumptions include:

 If SDC or Construction Observation services are extended beyond the above stated or additional work is required to complete the project as designated and intended, then a Supplement to this consultant services authorization may be requested by the CONSULTANT for this additional work.

- 2. Specialty inspections, including but not limited to civil, landscaping, structural, architectural, HVAC, electrical, and instrumentation and controls, are not included as part of the consultant services authorization. It is assumed the DESIGN-BUILDER will be responsible for providing such inspections.
- 3. The CONSULTANT is not responsible for certifying the project upon completion. It is assumed the DESIGN-BUILDER will be responsible for the Project final certification.
- 4. Materials testing services are not included in this consultant services authorization.
- 5. The CONSULTANT will not undertake any responsibilities of the DESIGN-BUILDER.
- 6. Record Drawings will be prepared by the DESIGN-BUILDER.
- 7. Specialty Inspections that may be required by the Building Department are not included as part of this consultant services authorization. It is assumed that the DESIGN-BUILDER is responsible for providing and coordinating any required specialty inspections.
- 8. Services associated with the CONSULTANT's attendance at factory and/or shop acceptance tests are not included in this consultant services authorization.
- 9. Services associated with the review of shop drawings, requests for information (RFI), and design clarifications are not included in this consultant services authorization. It is assumed that the DESIGN-BUILDER is responsible for the review of shop drawings and providing responses to any RFIs and design clarification items. The DESIGN-BUILDER will provide the CONSULTANT access to all approved shop drawings, RFIs, and design clarifications for use and reference during project inspection and oversight.
- 10. The DESIGN-BUILDER will provide the CONSULTANT with access to all project related documents.
- The DESIGN-BUILDER will be responsible for document control associated with the construction and will provide CONSULTANT access to their e-Builder document management system.
- 12. The DESIGN-BUILDER will provide the CONSULTANT a workstation in their construction field trailers. The workstation will be furnished with internet access.
- 13. Tracking and monitoring of the completion of warranty items after substantial completion of the project by the DESIGN-BUILDER is not included in this consultant services authorization. This effort may be added through a Supplement to this consultant services authorization should the need for this service be requested by the COUNTY.
- 14. The evaluation of substitute products and / or equipment proposed for the Project will be the responsibility of the DESIGN-BUILDER for review and acceptance by the COUNTY.
- 15. It is assumed that the DESIGN-BUILDER's onsite representative is ultimately responsible for ensuring the overall quality of the work and compliance with Contract Documents.




Location Map
